In producing herewith one accused person namely Prabin Biswakarma (31) S/O- Dri Chendre Biswakarma of Kamlanagar near Leaving Foundation School, Ward No- 42, PS- Bhaktinagar, Dist- Jalpaiguri along with following seized articles :-

1. 11 (Eleven) bottles of Royal Blue Whisky each bottle containing 750ML.
2. 01 (one) bottle of Royal stag Blended Whisky containing 375 ml.
3. 04 (four) bottles of Royal stag Blended Whisky each bottle containing 180ML.
4. 01 (one) bottle of Sterling Reserve Classique Blended Whisky B7 containing 375 ML.
5. 04 (four) bottles of Sterling Reserve Classique Blended Whisky B7 containing 180 ML.
6. 01 (one) bottle of MacDowell's No-1 Superior Whisky containing 180 ML.
7. 03 (three) bottles of kingfisher strong premium Beer each bottle containing 650 ML.

I, SI Sibdhan Karmakar of Bhaktinagar P.S. under Siliguri Police Commissionerate do hereby lodge a written complaint against Prabin Biswakarma (31) S/O- Dri Chendre Biswakarma of Kamlanagar near Leaving Foundation School, Ward No- 42, PS- Bhaktinagar, Dist- Jalpaiguri to the effect that today on 02.07.2021 at 18:05 hrs received a source information that one person namely Prabin Biswakarma has gathered huge quantity of illicit liquor in his house at Kamla nagar in order to sale the same to his design customers for his wrongful gain. Accordingly I diarized the fact in G.D. Vide Bhaktinagar P.S. G.D. E. No- 87 date 02/07/2021 and informed the fact to I/C Bhaktinagar P.S. and as per his direction myself along with ASI Biswajit Saha, ASI Rabin Lama, CV. 614 Sumit Roy, CV-619 Dharmendra Roy and CV 14 Labanyamoy Barman left for Kamlanagar under Bhaktinagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned his house cum residence where he kept illegal alcohol to sale his design customers. On arriving there found the above noted person who disclosed his identity as noted above who kept the same at his House in conceal position. On searching found huge numbers of above noted illegal liquor. On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 04 months for his wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 19.25 hrs to 20.35 hrs. On being asked he stated that he kept the same with a view to sale and supply at Kamlanagar area without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts rules for selling the said country made spirit and beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Prabin Biswakarma (31) S/O- Dri Chendre Biswakarma of Kamlanagar near Leaving Foundation School, Ward No- 42, PS- Bhaktinagar, Dist- Jalpaiguri as per proper section of law.
