

I SI Pradip Kr Singha of Ashighar OP under Bhaktinagar Police station, SPC do here by lodge a written complainant against six (06) accused persons namely (1) Sourav Saha (18) S/O Sanjay Saha Of Subhas Pally, Hatimore, PS Siliguri, Dist Jalpaiguri (2) Arnab Saha (22) S/O Dilip Saha Of Sukanta Nagar Auto Stand, PS Bhaktinagar Dist Jalpaiguri (3) Dilip Paul (28) S/O Shyam Paul Of Ghogomali Chayan Para, W/No 37, PS Bhaktinagar Dist Jalpaiguri (4) Suraj Oraon (31) S/O Lt Shihnath Oraon Of Khoribari, PS Falakata, Dist Alipurduar (5) Bijay Saha (25) S/O Late Prabin Saha of Bholanath Para Near Utsab Hotel PS Bhaktinagar Dist. Jalpaiguri and (6) Ricky Puri (32) S/O Nirmal Puri of Durganagar w/no. 40 PS Bhaktinagar Dist. Jalpaiguri, to the effect that today on 25.06.2021 at 13.55 hrs myself, ASI Sumit Baran Nath along with C/ 729 Dinesh Ch Roy and CV-1016 Amrit Roy while performing patrolling duty in connection with Covid -19 situation at Ashighar OP area vide Ashighar OP GDE no. 35 Date 02.07.2021, at about 15.55 hrs found that the above noted persons were roaming at Ashighar More without wearing Mask and without any purpose which has been duly promulgated by Government of West Bengal due to crucial situation of corona virus though the Government has abstained them not to come out of the house without any emergency requirement as it is very dangerous for our society at this stage. As Government has announced wearing of facial mask has been made mandatory in public place in current pandemic disaster situation to everybody vide order no. 79-CS/2020 dated 12.04.2020, Vide memo no. 486-CS/2021 dt 24.04.2021 and also announced lock down from 16th may to 31st May vide memo no. 647-ISS/2M-22/2020 DT 15.05.2021 and the same has been extended till 15.06.2021 and order no. 753-ISS/2M-22/2020 DT 14.06.2021 and the same has been extended till 15.07.2021 and order no. 753/11-ISS/2M-22/2020 Dt 28.06.2021 as it is very dangerous for our society at this stage. However the above persons violated the said rules and norms which has been duly promulgated by Government of West Bengal. Considering the present situation of West Bengal as well as Whole India. I warned them to wear Mask and follow the protocol of COVID-19 & Govt. order but they did not pay heed to my words and did not comply my lawful instructions and kept on roaming within the area without wearing Mask. As such, I arrested them under the provision govt order after observing all sort of rules.

Therefore, I pray before your kind honour that a Specific case may kindly incited against the accused persons namely (1) Sourav Saha (18) S/O Sanjay Saha Of Subhas Pally, Hatimore, PS Siliguri, Dist Jalpaiguri (2) Arnab Saha (22) S/O Dilip Saha Of Sukanta Nagar Auto Stand, PS Bhaktinagar Dist Jalpaiguri (3) Dilip Paul (28) S/O Shyam Paul Of Ghogomali Chayan Para, W/No 37, PS Bhaktinagar Dist Jalpaiguri (4) Suraj Oraon (31) S/O Lt Shihnath Oraon Of Khoribari, PS
