Sir,

In producing herewith one accused person namely Bidhyasagar Roy (60), S/O- Late Surendra Nath Roy of Naresh more Papiapara PS Bhaktinagar Dist Jalpaiguri and the following articles under seizure:

(1) 23 (Twenty three) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/- (Total-13.8 Liter & Amount Rs 2300/-)

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Bidhyasagar Roy (60), S/O- Late Surendra Nath Roy of Naresh more Papiapara PS Bhaktinagar Dist Jalpaiguri to the effect that, on 02.07.2021 evening as per order of O/C Ashighar OP I along with ASI Sumit Baran Nath C/ 877 Munna Ahamed, and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 30 Dt 02.07.2021 in course of which I received information from my source that one Bidhyasagar Roy stored a huge numbers of bottles liquor inside his house at Naresh more Papiapara and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Naresh more Papiapara area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinager Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjan Nager w/no 36 PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Naresh more Papiapara area as indicated by my source I held raid at the house Bidhyasagar Roy at Naresh more Papiapara. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 15.35 hrs and 15.55 hrs on 02.07.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Bidhyasagar Roy (60), S/O- Late Surendra Nath Roy of Naresh more Papiapara PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
