Sir,

I, ASI Subhnedu Das of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Ujjal Roy (42/M) S/O Lt. Kshitish Ch. Roy of Ghosh Para, ward No.11, PS- Dhupguri, Dist- Jalpaiguri (Pay Servent) under arrest along with following seized articles viz ; (I) 13 (Thirteen) bottles of Himalayan Gold Country Spirit each bottle containing 600ml. and marked as "Exhibit-A" (II) 01(one) bottle of Himalayan Gold Country Spirit containing 600ml. taken out as sample from "Exhibit-A" for examination and marked as "Exhibit-A-P" (total 13 X 600 ml. = 7.8 Ltrs.), (III) 10 (ten) bottles of Kingfisher Strong Beer each bottle containing 650ml. and marked as "Exhibit-B", (IV) 01(one) bottle of Kingfisher Strong Beer containing 650ml. taken out as sample from "Exhibit-B" for examination and marked as "Exhibit-B-P", (total 10 X 650 ml. = 6.5 Ltrs.) (V) 12 (Twelve) bottles of Mc Dowells No.1 Celebration RUM each bottle containing 180ml. and marked as "Exhibit-C", (VI) 01(one) bottle of Mc Dowells No.1 Celebration RUM containing 180ml. taken out as sample from "Exhibit-C" for examination and marked as "Exhibit-C-P" (total 12 X 180 ml. = 2.160 Ltrs.) under seizure list (which is enclosed herewith) to the effect that on 02.07.2021 at 16.15 hrs received a secret source information that huge quantity of liquor stored at "Oasis Hotel & Restaurant" at Kadamtala opp of Durga Mandir without any valid license. Diarized the matter vide Matigara PS GDE No.84 Dt.- 02.07.2021 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with ASI Nitai Ch. Mondal, Const- 1035 Santosh Rabi Das, CV- 155 Sukumar Das left for Kadamtala to verify the veracity of the source information. On reaching at the spot at 16:40 hrs it was found that huge quantity of liquor and Country Spirit stored inside the "Oasis Hotel & Restaurant" and one Ujjal Roy (Pay Servant) who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the Hotel. But we apprehend the above noted person namely Ujjal Roy. There after I called two independent witnesses namely i) Md. Khalilur Rahaman (52/M) S/O Lt. Md. Hasan Ali of Tarijot, PO- New Rangia, PS- Matigara, Dist- Darjeeling and (ii) Sanjoy Mandol (28/M) S/O Lt. Swapan Mandol of old Matigara road, ward No- 47, PS- Matigara, Dist- Darjeeling and in the very presence of those witnesses I search the Hotel and seized the above noted liquors and country spirit after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Ujjal Roy. On being asked the said person failed to produce any document for selling and storing liquor at the "Oasis Hotel Restaurant. It's a violation under Bengal Excise Act. This seizure was made on 02.07.21 in between 16:55 hrs to 17:40 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Ujjal Roy (42/M) S/O Kt. Kshitish Ch. Roy of Ghosh Para, ward No.11, PS- Dhupguri, Dist- Jalpaiguri after preparing memo of arrest and intimating the ground of arrest. On being asked he did not produced any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Ujjal Roy (42/M) S/O Lt. Kshitish Ch. Roy of Ghosh Para, ward No.11, PS- Dhupguri, Dist- Jalpaiguri and arrange for its investigation.
