Sir,

I, ASI. Nitai Mandal of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Akash Das (28/M) S/O Late Laxmi Das of Pati colony road no-8, PO-Pradhannagar, PS- Matigara, Dist- Darjeeling under arrest along with following seized articles viz ; (I) 15 (fifteen) bottles of Himalayan Gold Country Spirit each bottle containing 600ml. and marked as "Exhibit-A" (II) 01(one) bottle of Himalayan Gold Country Spirit containing 600ml. taken out as sample from "Exhibit-A" for examination and marked as "Exhibit-A-F" (total 15 X 600 ml. =9 Ltrs.), (III) 08 (eight) bottles of Kingfisher Strong Beer each bottle containing 650ml. and marked as "Exhibit-B", (IV) 01(one) bottle of Kingfisher Strong Beer containing 650ml. taken out as sample from "Exhibit-B" for examination and marked as "Exhibit-B-F", (total 08 X 650 ml. =5.2 Ltrs.) (V) 10 (Ten) bottles of Mc Dowells No.1 Celebration RUM each bottle containing 180ml. and marked as "Exhibit-C", (VI) 01(one) bottle of Mc Dowells No.1 Celebration RUM containing 180ml. taken out as sample from "Exhibit-C" for examination and marked as "Exhibit-C-F" (total 10 X 180 ml. =1.8 Ltrs.) under seizure list (which is enclosed herewith) to the effect that on 02.07.2021 at 18.15 hrs received a secret source information that one person namely Akash Das of Pati colony has stored huge quantity of liquor and country spirit at his Shop at Pati Colony under PS- Matigara without any valid license. Diarized the matter vide Matigara PS GDE No.92 Dt.- 02.07.2021 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with ASI Subhendu Das, Const- 1035 Santosh Rabi Das, CV- 155 Sukumar Das left for Pati Colony to verify the veracity of the source information. On reaching at the spot at 19:40 hrs it was found that huge quantity of liquor and Country Spirit stored in the Shop of Akash Das who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the Hotel. But we apprehend the above noted person namely Akash Das. There after I called two independent witnesses namely i) Rohit Basfore (19/M) S/O Raju Basfore of New colony, road no-7, PO- Pradhannagar, PS- Matigara, Dist- Darjeeling (ii) Golok Baroi (42/M) S/O Late Bhim Baroi of Simultala, PO+PS- Matigara, Dist- Darjeeling and in the very presence of those witnesses I search the Shop and seized the above noted liquors and country spirit after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Akash Das. On being asked the said person failed to produce any document for selling and storing liquor at the Shop. It's a violation under Bengal Excise Act. This seizure was made on 02.07.21 in between 20:05 hrs to 21:10 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Akash Das (28/M) S/O Late Laxmi Das of Pati colony road no-8, PO-Pradhannagar, PS- Matigara, Dist- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of liquor at the said Hotel and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Akash Das (28/M) S/O Late Laxmi Das of Pati colony road no-8, PO-Pradhannagar, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
