In producing herewith one person namely Prakash Chowhan 49yrs s/o Late Chandra Shekhar of Hathkhola PS, Bagdogra, Dist- Darjeeling under arrest along with following articles under seizure,

1. 15 (Fifteen) bottles of Himalyan Gold 60' Up country Spirit (each bottle containing 600 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A-1",
2. 06 (Six) bottles of Mc Dowell's No Celebration Matured XXX Rum (each bottle containing 180 ml.) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1",
3. 10 (Ten) bottle Kingfisher Strong Premium Beer (each bottle containing 650 ml.) marked as Exhibit "C" from which 01 bottle randomly taken out as sample and marked as Exhibit "C-1",
4. 06 (Six) bottle Sikim Deluxe Musk Brandy (each bottle containing 180 ml.) marked as Exhibit "C" from which 01 bottle randomly taken out as sample and marked as Exhibit "C-1",
5. One old and used big size white color refrigerator without styled.

I, ASI Jakirul Islam of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person namely Prakash Chowhan 49yrs s/o Late Chandra Shekhar of Hathkhola PS, Bagdogra, Dist- Darjeeling and absconding one Bimal lama s/o Dal Bahadur Lama of Airport more Bagdogra to the effect that today i.e, on 03.07.21 in course of special evening mobile duty around 20.05 hrs received a reliable source information that one shop situated and located at Airport More market conjointly business partner mentioned above that they possessing and selling huge quantity of illicit liquor on their shop located at Airport more to their designated customers. Accordingly, I shared the information with you and diarized the fact vide GDE no 118 and as per your kind instruction, I along with force immediately rushed to the Airtort More the shop under Bagdogra PS, to work out the information. On reaching there at about 20.15 hrs, I contacted with my source and subsequently being pointed the shop seeing the police party some of customers run to fled away somehow we managed to apprehended the above noted person from the shop on interrogation he admitted that he along with Bimal Lama doing the said business since few months as partnership also stated that said Bimal Lama fled away from the shop on search the above noted illicit liquor has been recovered from the shop storage one old and used big size white color refrigerator on demand he failed to produce any valid documents/papers in support of possessing and storing of huge quantity of the illicit. Accordingly, I seized the above noted illicit liquor and refrigerator under proper seizure list in presence of witnesses and labelled and also arrested him issuing memo of arrest. The whole process of seizure and labelled was made in between 20.25 hrs to 21.15 hrs.

Therefore, I pray that a specific case under proper section of law may kindly be recorded against Prakash Chowhan 49yrs s/o Late Chandra Shekhar of Hathkhola PS, Bagdogra, Dist- Darjeeling and one absconding Bimal lama s/o Dal Bahadur Lama of Airport more and arrange for its investigation.
