Sir,

In producing herewith one accused person namely Sudha Chettri(45) W/O- Sri Dipak Chettri of Shastrinagar near Bidyasagar School, PS- Bhaktinagar Dist-Jalpaiguri along with the following seized articles as per proper seizure list:

- 1) 04(four) bottles of Tubrog Premium Beer Strong each bottle containing 650 ML.
- 2) 01 (one) bottle of Kingfisher strong Premium Beer containing 650ML.
- 3) 07(seven) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml.
- 4) 02(two) bottles of Boss 60 up country spirit each bottle containing 600 ml.
- 5) 09(nine) bottles of Himalayan Gold 60 up country spirit each bottle containing 300 ml.

I, SI Sibdhan Karmakar of Bhaktinagar PS, SPC lodged a written complainant against Sudha Chettri(45) W/O- Sri Dipak Chettri of Shastrinagar near Bidyasagar School, PS- Bhaktinagar ,Dist- Jalpaiguri to the effect that today i.e. on 05.07.2021 at 09.15 hrs received a source information that one Lady of Shastrinagar has stored huge amount of liquor illegally at her house for selling the same to her design customer for her wrongful gain. Accordingly the fact is diarized vide Bhaktinagar P.S. GDE No-239 Date 05.07.2021 and informed to I/C Bhaktinagara P.S. about the information. As per his kind instruction I along with LSI Niden Sherpa ,ASI Rabin Lama ,CV-935 Biplab Roy, CV-619 Dharmendra Roy left for Shastrinagar to work out the information. At 09.35 hrs we reached at the spot and after a while identified by the source I conducted raid in the house of Sudha Chettri and recovered the above noted articles from the possession of above noted accused person namely Sudha Chettri(45) W/O- Sri Dipak Chettri of Shastrinagar near Bidyasagar School, PS- Bhaktinagar Dist-Jalpaiguri. On demand she could not produce any valid license/documents in support of said liquor. On interrogation she stated that she used sale the same to her design customers since long for his wrongful gain. Accordingly In presence of witnesses I seized the same as proper seizure list duly sign by the witnesses with the help of LSI Niden Sherpa . The seizure was made between 09.50 hrs to 10.20 hrs. Thereafter I arrested the said accused person with the help of Lady SI Niden Sherpa u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses after observing all sorts arrest rules.

I therefore request you a specific case may kindly be started against the accused person namely Sudha Chettri(45) W/O- Sri Dipak Chettri of Shastrinagar near Bidyasagar School, PS- Bhaktinagar Dist-Jalpaiguri under proper section of law.
