I, PSI Rantu Haldar of NBMC OP under Matigara PS, Siliguri Police Commissionerate, do hereby lodged this written complaint against one Sadhan Singha (33) S/O- Jharendra nath Singha of Thiknikata P.O- Sushrutanagar, P.S- Matigara, Dist- Darjeeling after producing him under arrest along with following articles:

- 1) 13 (Thirteen) Sealed Himalayan Gold Bottles 60Up Country Spirit each containing 600 ml Rs. 100/- each (Total Rs. -1300) contained in one carton under seizure.

In this regard, I beg to report that on 03/07/2021 at 12.05 hrs vide NBMC OP GDE No 83, I along with Const 131 Kanuram Sarkar, CV 158 Partha Sarakar while conducting special raid against Illicit liquor received an information that a person is selling illicit Liquor in huge quantity in a clandestine way at Thiknikata area. As soon as after receiving information I informed the matter to O/C NBMC OP and as per his order and instruction I conducted raid at Thiknikata. During raid I found one Sadhan Singha is possessing the above noted articles and selling it to the customers in counseled manner in his house. Accordingly, I seized the above noted articles in presence of police witnesses, I demanded him the papers or license, cash memo of the said liquor but he failed to produce any documents in support of possession of above noted illicit liquor. On interrogation, he disclosed his name as mentioned above and admitted that he procured the liquor illegally and had been selling the same illegally to the people. I, accordingly, seized those illicit liquors U/S 102 CrPC in presence of witnesses after preparing proper seizure List duly signed by the witnesses as well as the accused and also labeled the same. Then, I arrested him U/S 41 CrPC. The ground of arrest duly been communicated by him.

As the above noted seized articles are to be suspected be of Illicit Origin and possessing the same illegally. I, therefore, pray before your kind honor to take legal action against him under proper section of law.
