In producing herewith one arrested accused person named 1) Sosi Roy (M/25y), S/O- Lt. Ramesh Roy of Baniakhari, Tripalijote, P.S- Matigara, Dist- Darjeeling under arrest along with the following seized articles u/s 102 Cr.P.C viz,

1. Total 400 (Four Hundred) number of white colour plastic sacks containing Salt weight approx 50 (fifty) kgs each. The sacks are printed as "Decent Iodised Salt".
2. Total 30 (thirty) number of Orange Colour plastic sacks styled as "PARAS MURIATE OF NITRATE OF TATA CHEMICALS LIMITED."
3. One Closer Machine styled as "REVO" having Model No. DA (220-240 AC) along with two bundles of thread (white and red in colour)
4. One electronics weight machine styled as "COSMO",
5. Total 05 (five) numbers of plastic sacks containing duplicate fertilizer weight approx 50 kgs each.
6. One plastic sack containing 30 kgs brown chemical colour.
7. One plastic sack containing 1.5 kgs red chemical colour.

I, SI Newton Biswas of Matigara PS/SPC do here by lodge this written complaint to the effect that today i.e. 03.07.21 at 17.35 hrs received a specific secret source information from reliable source that an adulteration as well as mixing is going on for production of duplicate fertilizers at the house of Gobindo Barman of Baniakhari, Tripalijote area under PS- Matigara. Accordingly I diarized the matter in GDE vide Matigara PS GDE NO. 146 Dt. 03.07.21 and after informing the fact to O/C Matigara PS/SPC and as per kind order of superiors myself along with force SI Basudev Guha, ASI Subhendu Das, ASI Nitai Mondal, C/1035 Santosh Rabidas, C/1008 Kanak Barman, CV/ 155 Sukumar Das, CV/387 Sukumar Barman left for Baniakhari, Tripalijote area under PS- Matigara to work out the information. On reaching near to the spot I called two independent witnesses namely (a) Khokon Debnath, (M/28Yrs) S/O- Khudiram Debnath of Baniakhari, Tripalijote, P.S- Matigara, Dist- Darjeeling, (b) Ashok kr. Mukherjee, (M/69Yrs) S/O- Lt. Bhushan Ch. Mukherjee of Baniakhari, Tripalijote, P.S- Matigara, Dist- Darjeeling and informed them regarding the information and asked them to help the police team if needed.

At 18.05 hrs we reached at Baniakhari, Tripalijote area under PS- Matigara area. On being indicated by source, myself along with force entered inside the house of Gobindo Barman and found that four /five persons were engaged in filling up of duplicate fertilizer in new sacks inside the house and one person was standing outside of house. On seeing the police team they tried to flee away from the spot but somehow we managed to apprehend the above noted accused person. Other persons had managed to escape through the back side of the said house. We then conducted search in presence of independence witnesses. During search found huge numbers of adulterated/mixed plastic gunny bags of duplicate fertilizer stocked inside the house. On the other hand there were stocks of newly filled up duplicate fertilizer bags having printed as PARAS and also printed as marketed by Indorama India Private Limited. etc. Some loose duplicate fertilizer sacks were found scattered in the floor of the house. On being asked the apprehended accused failed to produce any valid document in support of the possession of the said items. The accused persons noted above admitted that he in connivance and under the direction of the owner named Gobindo Barman of the said house used to manufacture adulterated fertilizer of low price and repacking the fertilizer in bags bearing reputed company's names for their wrongful gain.

During interrogation and on enquiry, it could be revealed that accused as noted above in association with the owner of the said house had clandestinely running the illegal business of manufacturing duplicate fertilizer in comparatively low production price, mixing it with adulterated fertilizers and selling it off after re-packing it as genuine in the name of reputed fertilizer company since last few years without any license or permission of the appropriate authority for their wrongful gain. The accused persons were selling adulterated and spurious fertilizer in bags bearing the name of a reputed fertilizer company and thus causing harm to the reputation to the reputed fertilizer companies as well as the endanger the safety of the common people who purchased the said adulterated and spurious fertilizer contained in the packet believing it as genuine fertilizer of reputed fertilizer companies and thereby cheated the common public in general as well as the reputed fertilizer companies.

There after I accordingly seized the above mentioned articles from his possession in presence of witnesses under proper seizure list and I also took samples of duplicate fertilizers and properly sealed and labeled the seized articles in presence of witnesses. The whole process of seizure was made in between 19.05 hrs to 22.25 hrs. I accordingly arrested him under section 41 Cr.P.C issuing proper memo of arrest and apprised him about the ground of arrest and informed his family members.

Therefore, I pray that a specific case may kindly be started against the arrested accused person named 1) Sasi Roy (M/25y), S/O- Lt. Ramesh Roy of Baniakhari, Tripalijote, P.S- Matigara, Dist- Darjeeling and against the owner of the house named Gobindo Barman and also against their other associates under proper section of law.
