Sir,

With due respect, I am producing herewith the arrested accused person namely Pradip Bose (32 yrs) S/O Nepal Bose of Mamata Para, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 46 (Forty Six) bottles of 60 up Himalayan Gold Country Spirit containing 600 ml in each bottle of MRP Rs 100/- of each bottle.
2. 07 (Seven) bottles of 60 up Himalayan Gold of Country Spirit containing 300 ml in each bottle of MRP Rs 50/- of each bottle.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 02.07.21 at 12.55 hrs I received a secret source information that one person namely Pradip Bose of Mamata Para is selling ID liquor illegally at his residence at Mamata Para under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 71 dated 02.07.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, ASI Khagen Barman, C/1053 Paresh Rava, VP/08 Laxman Roy and VP/13 Jamirul Islam left for Mamata Para to work out the information in hand. At about 13.25 hrs we arrived at Mamata Para and being shown and identified by the source we held raid at the house of Pradip Bose of Mamata para and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his residence for his wrongful gain. On search the above noted I/D liquor recovered from their possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor at his residence. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 13.45 hrs and 14.25 hrs on 02.07.21.


