3. 04 (Four) bottles of KINGFISHER Strong premium Beer containing 650 Ml in each bottle of MRP Rs 130/- of each bottle.

I, SI Samik Paul presently attached with NJP PS under your kind control beg to state that today i.e. on 02.07.21 at 15.35 hrs I received a secret source information that one person namely Satish Roy of Sepai Para is selling ID liquor illegally at his residence at Sepai Para under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 80 dated 02.07.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Khagen Barman, C/1053 Paresh Rava, VP/08 Laxman Roy and VP/13 Jamirul Islam left for Mamata Para to work out the information in hand. At about 16.05 hrs we arrived at Sepai Para and being shown and identified by the source we held raid at the house of Satish Roy of Sepai Para and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his residence for his wrongful gain. On search the above noted I/D liquor recovered from their possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor at his residence. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 16.15 hrs and 16.45 hrs on 02.07.21.
