Nikhil Barman of Charkhata, PO. Bairagi Hat, PS- Mathavanga, Dist-Coochbehar (3) Manoranjan Barman (25yrs) S/o. Kalipada Barman of Charkhata, PO. Bairagi Hat, PS- Mathavanga, Dist-Coochbehar (4) Biplab Mallick (30 yrs) S/o. Lt. Paritosh Mallick of Pelkavita, PO. Sahudangi Hat, PS. NJP, Dist-Jalpaiguri under arrest with Memo of Arrest.

I, ASI. Biswajit Ghosh of Ambari Falakata OP under NJP PS beg to report that on 02.07.2021 at 13:55hrs in course of special mobile van duty vide Ambari OP GDE No- 62/2021 dated 02.07.2021 myself along with force namely (1) NVE/108 Swadesh Roy and (2) NVE/029 Kiran Roy had been to Canal More, under Ambari Falakata OP. PS. NJP and found the above noted persons were roaming without face mask at that area violated the Government Order (Lock Down) in c/w outbreak of COVID-19. Accordingly, the above noted persons were detained. On being interrogation they disclosed their identity as mentioned above and further they failed to give any satisfactory answer regarding their movement in that area rather they refuse to comply with direction of the Government Order regarding lockdown in c/w outbreak of Covid-19. Hence I arrested them u/s 41 Cr.P.C after issuing copy of Memo of arrest and inform their ground of arrest.

Therefore I pray before your good office that a specific case under proper section of Law may kindly be started against the above noted accused persons namely (1) Nanibhushan Roy (21 yrs), (2) Bapi Barman (19yrs) (3) Manoranjan Barman (25yrs) and (4) Biplab Mallick (30 yrs) and arrange for its investigation.
