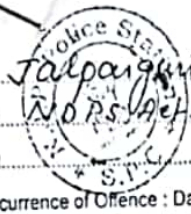

Sir,

In producing herewith the arrested accused person namely Ranjit Paul (43 yrs) S/O late Shankar Paul of Michel Madhu Sudan Colony, PS- NJP, Dist. Jalpaiguri along with the following seized articles under seizure as per seizure list :-

Total 07 (Seven) packets of said to be Ganja wrapped with Brown colour plastic Tape containing total 26.4 kgs said to be Ganja kept in a nylon bag which accused Ranjit Paul (43 yrs) S/O late Shankar Paul of Michel Madhu Sudan Colony, PS- NJP, Dist. Jalpaiguri carrying in his right hand and Marked as follows :-

- (i) Exhibit 'A' Contains 5.100 Kg. Said to be Ganja wrapped in a Brown colour transparent Tape.
- (ii) Exhibit 'B' Contains 2.500 Kg. Said to be Ganja wrapped in a Brown colour transparent Tape.
- (iii) Exhibit 'C' Contains 3.300 Kg. Said to be Ganja wrapped in a Brown colour transparent Tape.
- (iv) Exhibit 'D' Contains 2.500 Kg. Said to be Ganja wrapped in a Brown colour transparent Tape.
- (v) Exhibit 'E' Contains 5.100 Kg. Said to be Ganja wrapped in a Brown colour transparent Tape.
- (vi) Exhibit 'F' Contains 5.100 Kg. Said to be Ganja wrapped in a Brown colour transparent Tape.
- (vii) Exhibit 'G' Contains 2.800 Kg. Said to be Ganja wrapped in a Brown colour transparent Tape.

I, SI Samik Paul of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused person to the effect that on today i.e. 02.07.2021 at about 18.05 hrs received a specific source information that one person is standing at Hospital More, NJP with a nylon bag containing Ganja in his possession. Accordingly I informed the matter to SI Samir Tamang, O/C New Jalpaiguri PS, SPC regarding the information in hand and I diarized the fact in General Diary vide NJP PS GDE No. 88 dated 02.07.21 and as per order myself along with ASI Khagen Barman, ASI Sajal Das, C/1053 Paresih Rava, VP/13 Jamirul Islam, VP/08 Laxman Roy, all of NJP PS left PS for Hospital More by Govt Vehicle to work out the information in hand vide NJP PS MCC No 1590 dated 02.07.21 with necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box, charger light etc. Meanwhile, I called two disinterested witnesses namely 1) Sukamal Sen Gupta S/O Subir Sen Gupta of Saktigarh, PS- NJP, Dist.- Jalpaiguri 2) Suanya Bikash Ghosh S/O late Jyoti Prakash Ghosh of Purba Dhantala, PS- NJP, Dist.- Jalpaiguri and I disclosed our identity and informed them about the information in hand and requested them to accompany us, in the whole process of search and seizure, if any. At about 18.15 hrs we arrived at Hospital More and being shown and identified by the source we found one person standing at Hospital More with a nylon bag in his right hand. I along with ASI Khagen Barman, ASI Sajal Das, C/1053 Paresih Rava, VP/13 Jamirul Islam and VP/08 Laxman Roy detained the above noted person suspect along with 01 (one) nylon bag with handle in his right hand with strong reason to believe that he is illegally possessing Ganja in the bag in his right hand. We disclosed our identity as police personnel of NJP PS and I told him that as per reasonable information he is carrying contraband Ganja inside the bag in his possession. On being asked he disclosed his name and address as noted above. I told him about the information in hand but initially he denied. After prolong interrogation, he confessed that he has possessed Ganja in the bag in his possession. Then I gave him option that whether he wanted to be searched in presence and supervision of Executive Magistrate or police Gazetted Officer. He agreed to be searched in presence of police Gazetted Officer. Accordingly, I served the Notice in writing and as per provision of law to him which he duly acknowledged by receiving and signing in the copy of Notice. Accordingly, I informed Shri Pasang Topgay Bhutia, WBPS, ACP (Traffic) West, Siliguri Police Commissionerate regarding the apprehension of said person with said to be Ganja and requested him through messenger to come at Hospital More, NJP and remain present as Gazetted Officer during the time of search and seizure if any which he duly accepted. At 20.45 hrs Shri Pasang Topgay Bhutia, WBPS, ACP (Traffic) West, Siliguri Police Commissionerate arrived at the spot in uniform and disclosed his identity to the detained person and witnesses as Pasang Topgay Bhutia, WBPS, ACP (Traffic) West, Siliguri Police Commissionerate detailed as Special Executive Magistrate, Siliguri Police Commissionerate.
