Sir,

With due respect, I am producing herewith the arrested accused person namely Raj Kishor Mandal (50 yrs) S/O Late Suklal Mandal of Jyotirmoy colony, PS-NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 27 (Twenty Seven) bottles of 60 up Himalayan Gold Country Spirit containing 600 ml in each bottle of MRP Rs 100/- of each bottle.
2. 04 (Four) bottles of 60 up Himalayan Gold of Country Spirit containing 300 ml in each bottle of MRP Rs 50/- of each bottle.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 03.07.21 at 13.15 hrs I received a secret source information that one person namely Raj Kishor Mandal of Jyotirmoy Colony is selling ID liquor illegally at his shop at Jyotirmoy Colony under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 123 dated 03.07.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, ASI Khagen Barman, C/1053 Paresh Rava, CV/824 Niru Kumar Yadav left for Jyotirmoy Colony to work out the information in hand. At about 13.45 hrs we arrived at Jyotirmoy Colony and being shown and identified by the source we held raid in the shop of Raj Kishor Mandal of Jyotirmoy Colony and managed to apprehended him. During interrogation he disclosed his wrongful gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor at his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 14.05 hrs to 15.25 hrs on 03.07.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Raj Kishor Mandal (50 yrs) S/O Late Suklal Mandal of Jyotirmoy Colony, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
