Sir,
In producing herewith one accused person namely Laxman Roy (45yrs) S/O Lt. Bazaru Roy of Farabari, Velkipara, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. One (01) Bottle of MC. Dowell's Luxury Premium Whisky containing 750 ML.
2. Three (03) Bottle of Cosmos Fifty Deluxe Whisky containing 750 ML each.
3. Three (03) Bottles of Kingfisher strong premium Beer (each bottle containing 650 ML).
4. Twelve (12) Pet Bottles of Galaxy Boss 60 up country spirit (each bottle containing 600 ML).

I, SI. Phup Rinchey Bhutia of Ambari Falakata out post under NJP PS, SPC lodged a written complainant against the above noted person to the effect that today on 03.07.2021 at 14:15hrs received a source information that in the house of Laxman Roy (45yrs) S/O Lt. Bazaru Roy of Farabari, Velkipara, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata out post GDE No-100 dated 03.07.21. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1)ASI. Ramprasad Adhikary (2) NVF/159 Debranjana Sarkar and CVF/01 Jay Chand Roy proceed to Farabari, Velkipara to work out the information. At 16.05 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the house of Laxman Roy (45yrs) S/O Lt. Bazaru Roy and recovered the above noted articles from the possession of above noted accused person namely Laxman Roy (45yrs) S/O Lt. Bazaru Roy of Farabari, Velkipara, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Ajit Roy S/o Buddiman Roy of Farabari-Velkipara, PO. Sahudangi Hat, PS-NJP Dist-Jalpaiguri 2) C/ 975 Swarup Basak S/O Gobinda Basak of Ambari Falakata OP, PS. NJP, Dist Jalpaiguri/SPC. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 16.05 hrs to 16.35 hrs. I arrested the said person u/s 41 Cr.P.C. an issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Laxman Roy (45yrs) S/O Lt. Bazaru Roy of Farabari, Velkipara, PO-Sahudangi Hat, PS-NJP Dist Jalpaiguri under proper section of law.
