Sir,

With due respect and humble submission I beg to lodge written complain against the person namely Tajul Md (M/ 35 yrs) S/O Late Mojibar Rahaman of Vill. Asharu Busty P.O - Asharu Busty & P.S Chopra Dist. Uttar Dinajpur (Driver of TOTO) found that the above noted accused person pertaining in order to restrict the unnecessary movement of vehicular traffic for combating the spread of COVID-19 in with out mask as per order of Chief Secretary Govt. of West Bengal Vide Order No. H & FW/120 Dt. 22/03/2020 & MHA order No.40-3/2020-DM -I(A) Dated 24/03/2020, plying his TOTO without any valid reason or authority though order has already been promulgated nation wide in order to combating the spread of COVID-19. Hence he violated the said order. Finding no any alternative way I arrested him u/s 41(1)(a) Crpc. after properly briefing him about the ground of arrest and supplied a copy of memo of arrest. Accordingly, I seized his TOTO (E-Ricksaw) body red in colour, roof sky in colour. After preparing proper seizure list duly signed by the witnesses. Later on the arrested accused person released on Bail/PR bond and the seized TOTO have been given zimma to reliable surety in anticipation for kind approval of Ld. Court, with a direction to produce himself before the Ld. Court

Hence, I would, therefore request you to kindly start a specific case u/s 188 IPC r/w section 51(b) of Disaster management Act 2005 against the above noted accd. Person and obliged.
