In producing herewith three (03) arrested accused persons namely (i) Ranjit Barman (19), S/O Gajin Barman of Promod Nagar near Primary School, PS-Matigara, Dist- Darjeeling, (ii) Pradip Roy (32), S/O Chatradhar Roy of Panchanai, PS-Matigara, Dist - Darjeeling, (iii) Prasanta Sukla (25), S/O Anant Prakash Sukla of D-205, D-Block, Ganesh Nagar, Pandev Nagar Complex, Delhi arrested u/s 41 Cr.P.C.

I, SI Md. Sanaullah of Matigara PS SPC to the effect that on 04.07.2021 during performing Mobile Van duty near Barsana Hotel under Matigara PS area, he found three persons namely (i) Ranjit Barman (19), S/O Gajin Barman of Promod Nagar near Primary School, PS-Matigara, Dist- Darjeeling, (ii) Pradip Roy (32), S/O Chatradhar Roy of Panchanai, PS-Matigara, Dist - Darjeeling, (iii) Prasanta Sukla (25), S/O Anant Prakash Sukla of D-205, D-Block, Ganesh Nagar, Pandev Nagar Complex, Delhi were loitering near Barsana Hotel under Matigara P.S area without wearing mask and not maintaining social distance and violating the Govt. Order vide No.403/2020-DM-1 (A) Date- 29.04.2021. Accordingly, I warned them but they did not pay heed any words and my lawful instruction as such, I arrested them observing all sorts of arrest rules.

Therefore, I pray before your kind honour that a specific case may kindly be started against the accused persons namely (i) Ranjit Barman (19), S/O Gajin Barman of Promod Nagar near Primary School, PS-Matigara, Dist- Darjeeling, (ii) Pradip Roy (32), S/O Chatradhar Roy of Panchanai, PS-Matigara, Dist - Darjeeling, (iii) Prasanta Sukla (25), S/O Anant Prakash Sukla of D-205, D-Block, Ganesh Nagar, Pandev Nagar Complex, Delhi under proper section of law and arrange for its investigation.
