Respected Sir,

With due respect I, **SRI NEREY ORAON @ LALCHI ORAON**, Son of Late Langra Oraon, resident of Goyal Jote, Nemai, Post Office Nemai, Police Station Matigara, District Darjeeling, West Bengal would like to inform you that one Jharia Oraon, Son of Late Birsia Oraon, my grandfather, was the absolute owner of land measuring 4.96 acres, situated within Mouza Panchkelguri, J.L. No. 59, in L.R. Plot No. 109 (area 0.02 acres), L.R. Plot No. 110 (area 4.72 acres), L.R. Plot No. 111 (area 0.08 acres), L.R. Plot No. 112 (area 0.04 acres) & L.R. Plot No. 113 (area 0.10 acres), recorded in khatian no. 32, Police Station Matigara, District Darjeeling, and he had been possessing and enjoying the said land having permanent, heritable and transferable right, title and interest therein, free from all encumbrances and charges whatsoever. That my predecessor, Jharia Oraon, died intestate leaving behind him one son namely Sri Budhu Oraon and one daughter Smt Birshi Oraon @ Sanchari Oraon as his only legal heir and successor and the said Sri Budhu Oraon and Smt Birshi Oraon @ Sanchari Oraon jointly inherited the said property described in the schedule below in equal shares and as such, they became the joint owners of the property described in the schedule below having 50% undivided share each. That I am the son of one of the legal heir of Birshi Oraon @ Sanchari Oraon.

That I filed one Partition suit being no. 99 of 2016 before the Ld. Civil Judge Junior Division, Siliguri against Radheshyam Agarwal and others (**Copy of the Title suit Partition 99/2016 is annexed "A" herewith**) on 08.12.2016 and later on Ld. Court after hearing pleased to passed "Status Quo" order on 08.12.2016 (**Copy of the order dated 08.12.2016 is Annexed "B" herewith**) and the said order is still continuing. That today at about 11.30 A.M while I was going to my place of residence I found that the manager of Radheshyam Agarwal namely **SUBRATA KAR** S/O not known, **SMT NIRMALA PATHAK**, Wife of Sri Urbidhar Pathak, **SRI URBIDHAR PATHAK** S/O not known, son in law of **SRI URBIDHAR PATHAK** all are resident of Nemai, Post Office Nemai, Police Station Matigara, District Darjeeling along with five to ten antisocial persons gathered upon the suit land with heavy vehicle, out of them one disclosed that he is a Amin and they are trying to change the nature and character of the suit land. That when I asked them way they are gathered upon the suit land they started abusing me and they also beat me and also abused me by saying "Tribal Kutta harami jaat.....". Thereafter I started capturing video through mobile phone they fled away with a threat to come again and grab the land.

So the aforesaid persons are very desperate in nature and there is every possibility that they might grab my land by illegal means.

I shall be highly obliged for this act of kindness.
