I, SI Subir Chowhdury of Matigara PS SPC to the effect that on 04.07.2021 during performing Mobile Van duty at NBU gate No-2, Shivmandir under Matigara PS area he found Three persons namely (i) Jagannath Das (24), S/O Nepal Das of Rahjarammohan Roy, PS- SLG, Dist - DJG, (ii) Tapan Roy (23), S/O Sudhir Roy of Bhangapol, PS - MTG, Dist- DJG, (iii) Md.
