I, SI Gautam Mallick of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the above noted accused person to the effect that on today i.e 06.07.2021 at 06.15 lirs, received specific source information that one person would be coming to Tinbatti More under NJP PS for proceed to Coocbehar with some contraband medicines for illegal selling purpose for his illegal gain. Accordingly, I inform the matter to the O/C, NJP PS and diarised the matter in GD book vide NJP PS GDE No. 258, Dated- 06.07.21. At the same time I along with force accompanied by a special team of D.D. SPC headed by SI Mrityunjay Roy along with force viz. C/562 Utpal Saha, C/545 Krishna Barman, C/932 Pabitra Das all of D.D., SPC left NJP PS for verify the veracity of the information by Govt. Vehicle taking necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc vide NJP PS M.C.C. No. 1615/21, Dated- 06.07.21. At about 06.20 hrs we reached at Tinbatti More in front of Beekay Plaza and parked the vehicle at considerable distance and hidden ourselves inside the Beekay Plaza. Meanwhile, I called two disinterested witnesses namely 1) Pappu Sahani, S/o- Laxman Sahani of Kashmir Colony, Tinbatti More, PS-NJP, Dist-JPG. and 2) Nirmal Debnath, S/o- Lt. Harekrishna Debnath of Kashmir Colony, PS- NJP, Dist- JPG. I disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure, if any. Meanwhile, our Police party started looking for accused and finally as per source indication, at about 06.45 hrs, we saw a person was coming towards Beekay Plaza from Tinbatti More with a nylon bag in his hand. That bag seemed partially loaded. On seeing us he tried to flee away but somehow we could managed to apprehended him and detained him with a strong reason to believe that he possesses illegal consignment of contraband medicines in the bag and the secret source information seemed to be matched with appearance of said person. I disclosed our identity to him. On being asked he disclosed his name and address as noted above and also admitted that he is possessing the said contraband medicines in that bag. I, then, gave him option notice in writing that
