1. 168(one hundred & sixty eight) bottles of special Lemonex ,white disinfectant fluid & freshner said to be "phenyl" where I written manufacture by R.K. product, Kalkata-700001each bottle containing 500 Ml.

 60(sixty) bottles of New Clean up Black phenyl said to be phenyl where in written the powerful germ cleaner manufactured by R.K. Enterprise, Kalkata each bottle containing 450 MI.

 216 (Two hundred 7 Sixteen) empty bottles white colour and 65 pices red colour capmade by plastic.

Bhaktinagar Police Station under Siliguri Police I, SI Sibdhan Karmakar of Commissionerate do hereby lodged this written complaint against; (1) Rintu Ghosh (32) S/O- Late Naren Ghosh of Bidyachakra Colony near Sitala Mandir Goli, PS- Bhaktinagar, Dist- Jalpaiguri, (2) Bharati Das (40) W/O- Lakshan Das of Dakshin Ektiasal (Near Hat), P.S.- Bhaktinagar, Dist [alpaiguri and (3) Tumpa Dutta (28) W/O- Bappa Dutta of Lakshmi Colony Ward No- 44 ,PS-Bhaktinagar, Dist- Jalpaiguri to the effect that today on 06.07.2021 at about 13.05 hrs. while myself along with ASI Biswajit Saha, ASI Biplab Kumar Das, CV-619 Dharmendra Roy and CV-14 Labrayamoy Barman were performing P.C. mobile duty at Haiderpara area vide Bhaktinagar P.S.G.D.E. No- 296 date 06/07/2021, at that time I received an information from my secret source some women were preparing duplicate phenyl without any valid documents in order sale same in the open market for their wrongful gain in a rental house of Gopal Das situated at. Accordingly, I shared the information with I/C, Bhaktinagar P.S., who directed me to wait for some After a while, Sri Amaresh Singh, I/C Bhaktinagar along with LSI Niden Sherpa arrived at -Thereafter, myself along with force accompanied with I/C, Bhaktinagar P.S. reached at the spot and as shown and identified by the source, we cordoned the house of Gopal Das and entered in to the rested room of Tumpa Dutta and found that two women and one male person were packing and putting bottle caps in bottles seemed to be and having smell of phenyl but no instruments made be found for preparing phenyl. Inside the room found huge number of already filled up because having label in the name of R. K. enterprise / R. K. Products, Kolkata and also empty plastic bottles caps, identical to the bottles which contained phenyl like substance and bottles

caps put thereon. On being asked the above noted accused persons disclosed their name and address as noted above and also disclosed that they have been preparing duplicate phenyl since last 04 months in order to sell the same in open market in high price for their wrongful gain. Regarding labels of R. K. enterprise / R. K. Products, Kolkata, they all admitted that they had prepared forged label and using the same as genuine to cheat the people. They also admitted that they claimed themselves in the locality as bonafied persons to manufacture Phenyl but had no knowledge of preparing Phenyl. On interrogation and demand the accused person failed to produce any valid document or any valid licenses for preparing the said articles also confessed that they have been running this illegal business to cheat the common people of Siliguri area. Then, in presence of witnesses namely (a) Malin Ch. Roy(26),s/o Manoranjan Roy of Dakhin Palash, Natun Bazar, PS- Bhaktinagar, Dist,-Jalpaiguri and (b) CV-14 Labanyamoy Barman of Bhaktinagar P.S. above noted articles under proper seizure list and duly singed by the accused persons as well as witnesses and took into custody as alamat property. The seizure was made in between 14:25 hrs to 15:05 hrs. Hence I took them into custody after observing all the guidelines of Honorable Apex Court regarding arrest.

During preliminary enquiry, it could be learnt that the above noted arrested accused persons were cheating the common people preparing duplicate phenyl preparing and using forged label impersonating themselves as bonafied persons to manufacture Phenyl.

Hence, it is prayed that a specific case may kindly be started against the accused namely; (1) Rintu Ghosh(32) S/O- Late Naren Ghosh of Bidyachakra Colony near Sitala Mandir Goli PS-Bhaktinagar, Dist- Jalpaiguri, (2) Bharati Das (40) W/O- Lakshan Das of Dakshin Ektiasal near Hat, P.S.- Bhaktinagar Dist Jalpaiguri and (3) Tumpa Dutta (28) W/O- Bappa Dutta Lakshmi Colony Ward No- 44, PS- Bhaktinagar, Dist- Jalpaiguri and arrange for its investigation.
