I, SI Sibdhan Karmakar of Bhaktinagar P.S. under Siliguri Police Commissionerate do here by lodged a written complaint against Rajesh Sunwar (32) S/O- Lt. Phulnan Sunwar of Toribari, PO-Salugara, PS- Bhaktinagar, Dist.- Jalpaiguri to the effect that today on 06.07.2021 while I was performing Special raid duty as per order of my superior vide Bhaktinagar PS GDE NO- 322 date 06.07.2021, received a specific input from the source at 18.35 hrs that the above noted person has kept huge numbers of illicit liquor in his IAI K Resturent at Toribari, PO- Salugara, PS- Bhaktinagar, Dist.- Jalpaiguri, in order to clandestinely dispose the same. Accordingly the fact is informed to I/C Bhaktinagar PS and as per his direction I along with ASI Biplab Kumar Das ,CV. 614 Sumit Roy ,CV-935 Biplab Roy left for IAI K Resturent at Toribari, PO- Salugara, PS- Bhaktinagar, Dist.- Jalpaiguri to verify the veracity of the information. On reaching there and as identified by source cordoned the Resturent where he kept illegal alcohol. On arriving there found the above noted person who disclosed his identity as noted above who kept the same at his restaurant in conceals position. On searching found huge numbers of above noted seized Articles. On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 04 months for wrongful gain. Accordingly I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 18.55 hrs to 19.35 hrs. On being asked he stated that he kept the same with a view to sale and supply at Toribari, PO- Salugara area without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said country made spirit and beer without valid license.

Therefore I pray before your honour that a specific case may kindly be started against accd. Rajesh Sunwar (32) S/O- Lt. Phulnan Sunwar of Toribari, PO- Salugara, PS- Bhaktinagar, Dist.-Jalpaiguri as per proper section of law.
