Sir,

In producing herewith the seized 26 (Twenty Six) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 300 ML, MRP Rs.50/- (Total-7.8 Liter & Amount Rs 1300/-) and lodged a written complaint against the accused person namely Smt Anjali Das (48), W/O Sri Khagen Das of Ghogomali Bazar Near Post office PS Bhaktinagar Dist Jalpaiguri.

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person Smt Anjali Das (48), W/O Sri Khagen Das of Ghogomali Bazar Near Post office PS Bhaktinagar Dist Jalpaiguri, to the effect that, on 06.07.2021 evening as per order of O/C Ashighar OP I along with ASI Sumit Baran Nath C/877 Munna Ahamed, and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no 168 Dt 06 07 2021 in course of which I received information from my source that one Anjali Das stored a huge numbers of bottles liquor inside her house at Ghogomali Bazar Near Post office and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Ghogomali Bazar Near Post office area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinager Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjnan Nager w/no 36 PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Ghogomali Bazar Near Post office area as indicated by my source I held raid at the house of Anjali Das at Ghogomali Bazar Near Post office. But the lady accused person managed to escape from the spot. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside her house. I seized the above noted articles as alamath of the case, as none could be able to produce any documents for such illegal possession of such articles. During enquiry I came to know the name and address of lady accused person is noted above. The Search and seizure were made in between 15.55 hrs and 16.15 hrs on 06.07.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Smt Smt Anjali Das (48), W/O Sri Khagen Das of Ghogomali Bazar Near Post office PS Bhaktinagar Dist Jalpaiguri, and arrange for its investigation.
