 04 (four) bottles of Kingfisher Strong premium beer each bottle containing 650 Ml. 2) 07(seven) bottles of TUBORG Premium Beer Strong each bottle containing 650 ML.

3) 04(four) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. manufactured by Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal.

4) 02(two) bottles of Boss 60 up Country sprit each bottle containing 600 ml.

01(One) bottle of Royal Blue premium whisky containing 750 MI.

1, SI Sibdhan Karmakar of Bhaktinagar PS, SPC lodged a written complainant against Sajal Lama (37) W/O- Dorjee Lama of Salugara of Salugara Bazar PS- Bhaktinagar ,Dist- Jalapaiguri to the effect that today i.e. on 07.07.2021 at 14.20 hrs received a source information that one Lady of Salugara Bazar has stored huge amount of liquor illegally at her Restauran name and style as "Annapurna Restaurant" for selling the same to her design customer for her wrongful gain. Accordingly the fact is diarized vide Bhaktinagar P.S. GDE No-374 Dated 07.07.2021 and informed the fact to I/C Bhaktinagará P.S. and as per his kind instruction I along with LSI Niden Sherpa ,ASI Biplab Kumar Das ,CV-935 Biplab Roy, CV-614 Sumit Roy left for Salugara to work out the information. At 14.45 hrs we reached at the spot and after a while identified by the source. I conducted raid in the house of Sajal Lama (37) W/O- Dorjee Lama of Salugara of Salugara Bazar PS- Bhaktinagar ,Dist- Jalapaiguri and recovered the above noted articles from the possession of above noted accused person namely Sajal Lama (37) W/O- Dorjee Lama of Salugara of Salugara Bazar PS- Bhaktinagar ,Dist- Jalapaiguri. On demand she could not produce any valid license/documents in support of said liquor. On interrogation she stated that she used sale the same to her design customers since long for his wrongful gain. Accordingly in presence of witnesses I seized the same as proper seizure list duly sign by the witnesses with the help of LSI Niden Sherpa . The seizure was made in between 14.55 hrs to 15:35 hrs. Thereafter 1 arrested the said accused person with the help of Lady SI Niden Sherpa u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses after observing all sorts arrest rules.

I therefore request you a specific case may kindly be started against the accused person namely Sajal Lama (37) W/O- Dorjee Lama of Salugara of Salugara Bazar PS- Bhaktinagar ,Dist-Jalapaiguri under proper section of law.
