Respected Sir,

With due respect, I Prakash Das (34yrs), son of Sudhan Chandra Das resident of Bhimbar Bidhan Nagar PS Phansidewa, state that I along with Majharul Islam age 37 yrs, Ravi Mondal, Dilip Singh and Sunil Singh was returning home from Siliguri to Bidhan Nagar via Hyundai Creta white colour bearing registration number WB74BD 6377 on 6-7-2021. That the Majharul Islam son of Abdul Rof was driving the above mention vehicle. Thereafter around 8:30 pm at Gosainpur Opposite to Uttara Apartment Asian Highway 02, a black colour Mahindra Scorpio bearing registration number WB02AQ 5432, came from opposite lane at high speed, crashed the divider and hit my vehicle from front side. That the Scorpio driver was driving dangerously and recklessly. Due to this rash driving, I along with all co-passenger got injured. Thereafter we had a primary treatment at Bagdogra Primary Health Care. That the driver Majharul Islam was severely injured and was admitted to Neotia getwel Hospital. Even I also had a severe head injury.
