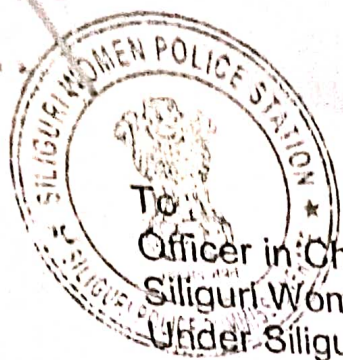

I, Smt. Sudha Chaudhary, Wife of Sri Mohan Kumar, Presently residing at Abhishek Apartment, Bankim Chandra Road, Hakimpara, Siliguri, P.O. and P.S.- Siliguri, Dist.- Darjeeling, Pin-734001, would like to inform you that on 24/05/1989 my marriage was solemnized with Sri Mohan Kumar, Son of Jeeban Prasad as per Hindu Rites and Customs. Out of our marriage two children were born namely Sneha Kumari and Nihal Kumar. After our marriage my husband's behavior towards me started to seem indifferent. My husband started to assault me physically by asking to get huge amount of cash from my parents house to start his business. Thereafter upon being physically assaulted on several occasions I intimated the same to my parents and thereafter my father gave cash to my husband according to his financial status. For several years my husband's brutal behavior towards me continued to be the same. Whenever I used to deny my husband to get cash from my father my husband used to assault me by slapping me and with kicks and blows. On several nights my husband used to come home at late night and throw me out of the house for the entire night without any reason. Moreover my husband on several times used to lock the main door from outside and take away the key with him keeping me and my children inside the house. My marital life remained the same for several years and is still continuing.


Suddenly on 03rd July 2021 my at about 4:00 to 5:00 AM my husband entered my bedroom where I was sleeping with my daughter ^{at Hakimpara resic} my husband suddenly put a pillow on my face and pressed hardly, trying to stop my breathing. When I tried to release myself, my daughter woke up and pushed my husband saving my life. Thereafter my husband pulled my hair and threw me on the floor. My husband started to shout and threatened me to kill me if I lodge any complaint against him at any
