

Sir,

In producing herewith two (02) arrested accused persons namely; 1) Susanta Saha 23yrs s/o Sukumar Saha of Samamagar ps, Bhaktinagar Dist, Jalpaiguri 2) Santosh Das 32yrs s/o Amar ch. Das of Namada Bagan ps, Pradhannagar Dist, Darjeeling with the following seized articles under proper seizure as per seizure list;

- a) One plastic zipper packet containing, 100 grams of NDPS substance believed to be Brown sugar recovered from the possession of Susanta Saha which was kept concealed on his right side pant pocket (front) wrapped by a part of Bengali News Paper styled as "Ananda Bazar Potrika" on dated 03.07.2021 Marked as - "Exhibit A" and out of which 10 grams are taken randomly as Sample for examination at CFSL, and marked as "Exhibit A-1"
- b) One smart Mobile phone VIVO with one SIM vide connection no 9339805119 recovered from the possession of accd, Susanta Saha
- c) One plastic zipper packet containing, 50 grams of NDPS substance believed to be Brown sugar recovered from the possession of Santosh Das which was kept concealed on his left side pant pocket (front) Marked as - "Exhibit B" and out of which 10 grams are taken randomly as Sample for examination at CFSL, and marked as "Exhibit B-1"
- d) One keypad Mobile phone styled as SAMSUNG with one SIM vide connection no 8170918105 recovered from the possession of accd, Santosh Das.
- e) One Part of Bengali News Paper styled as "Ananda Bazar Potrika" on dated 03.07.2021.

I, SI Bapi Ch Dey of Bagdogra P.S. S.P.C do hereby lodged this written complaint against the above noted two arrested persons (Add, not verified) to the effect that today on 08.07.2021 at 12.15 hrs. I received a specific reliable source information from my source that two persons is coming from Naxalbari and get down at Kestopur More and waiting for avail any bus also stated that they carrying huge quantity of NDPS substance Brown Sugar for delivering the same to their designed customers at in and around Ghoshpukur, Islampur area. Further, source stated that he was at Kestopur More and he would identify and show the accused persons. I requested him to be remain at that place and assist Police, to which he agreed. I accordingly shared the information with the Officer in Charge, Bagdogra PS, SPC in writing and diarized the fact vide Bagdogra PS GDE No. 436 dated 08.07.2021 and subsequently, as per direction of O.C. PS, I along with ASI Dharendra Nath Mondal, ASI Jakirul Islam, Const- 410 Mantosh Singh, VP/01 Ansalam Kujur, VP/02 Pradip Roy, CV/389 Janak Singha all of Bagdogra PS, SPC, carry with investigation kit, gala seal, candle, match box, weighing machine (Certified by Weight and metallurgy Department), etc. left for Kestopur More under Bagdogra PS, by govt. Vehicle (hired) to verify the veracity of the information vide Bagdogra PS GDE no. 437 dated


08.07.2021 and MCC No. 1091/2021 dated 08.07.2021 at 12.25 hrs, under this circumstance any search warrant or authorization cannot be obtained for not affording opportunity for the concealment of evidence or facility for the escape of the offender.

At around 12.40 hrs, I along with accompanying officer and force reached at near Kestopur area parked the vehicle in a considerable distance, and proceeded towards Kestopur more on foot we reached near Kestopur More and contacted source, who stated that he would assist us and present at that place. Meanwhile, I approached two persons on that locality namely i) Sri Kamal Biswas 52yrs s/o Krishna Biswas of Kestopur Chowpukuria PS Bagdogra, Dist. Darjeeling ii) Sri Subasish Das 49yrs s/o Late Deben Das of Kestopur Chowpukuria PS Bagdogra, Dist. Darjeeling and shared the information in hand with writing them and requested them to act as witness, if any search and seizure. They both agreed to remain with us. I along with officers, force, witnesses and source started keeping watch on the above described two persons on that area.

In course of search at Kestopur more around 12.55 hrs, source being point out two male young person's standing beside the road seeing the police party, they tried to flee away from the spot but somehow, we managed to apprehend them seeing their activities there is a strong reason to believe that they were possess something illegal on their possession. Accordingly, we disclosed our name and identity to them as Police officers from Bagdogra PS. On interrogation they disclosed their name and identities as noted above. Then, I share them the information in written regarding consignment of NDPS substance believed to be **Brown Sugar** kept concealed with their possession. I asked them whether they wanted to be searched in presence of Executive Magistrate or Gazetted Officer or not, then they agreed to be searched in presence of any of them. I also served Notice u/s 50 of NDPS Act to them in accordance with the Provision of Law individually in this regard which they duly acknowledge in written to search their body.

Then I, informed the matter to O/C Bagdogra PS, over phone and as per his kind instruction at around 13.10 hrs, I sent a letter through C/410 Mantosh Singh, in the same vehicle on which we had come for raid to Shri Chandan Das, Asstt. Commissioner of Police West Zone-II, SPC who had been detailed to act as Special Executive Magistrate of SPC for the day, informing him regarding the interception of the accused persons and suspected to be possessing huge quantity of believed to be **Brown Sugar** and with a request him to come down at Kestopur More and remain present to supervise the search and seizure as early.

At 15.20 hrs, Shri Chandan Das, Asstt. Commissioner of Police West Zone-II, SPC, who had been detailed to act as Special Executive Magistrate of SPC for the day arrived at the spot as Special Executive Magistrate, SPC and in presence of two independent witnesses and under his supervision, I, offered the independent witnesses and the accused persons to search our Police Party as per provisions but, they did not search the police party. Then, I search the above noted apprehended persons observing all formalities keeping their decency and while search of Susanta Saha recovered one plastic zipper packet wrapped with a part of Bengali news paper styled as "Ananda Bazar Potrika" on dated 03.07.21 after weighing by the weighing machine containing 100 grams of NDPS substance believed to be **Brown sugar** recovered from his possession which was kept concealed on his right side pant pocket (front) and further search one smart Mobile phone VIVO with one SIM vide connection no 9339805119. On search Santosh Das one plastic zipper packet after weighing by the



weighing machine containing 50 grams of NDPS substance believed to be Brown sugar which was kept concealed on his left side pant pocket (front) and one keypad Mobile phone styled as SAMSUNG with one SIM vide connection no 8170918105 recovered from his possession. On demand both the detained persons failed to produce any valid document in support of possessing of the suspected NDPS substance believe to be brown sugar from their possession also stated that they procuring the same from Nepal side and sell at Ghoshpukur, Islampur area to their designated customers in a high price. Accordingly, I seized all the above noted mentioned articles under proper seizure procedure and sealed, labeled the same as follows a) One plastic zipper packet containing, 100 grams of NDPS substance believed to be Brown sugar recovered from the possession of Susanta Saha which was kept concealed on his right side pant pocket (front) Marked as - "Exhibit A" and out of which 10 grams are taken randomly as Sample for examination at CFSL, and marked as "Exhibit A-1" b) One plastic zipper packet containing, 50 grams of NDPS substance believed to be Brown sugar recovered from the possession of Santosh Das which was kept concealed on his left side pant pocket (front) Marked as - "Exhibit B" and out of which 10 grams are taken randomly as Sample for examination at CFSL, and marked as "Exhibit B-1" c) Part of one Bengali News Paper styled as "Uttar Banga Sambad" on dated 06.07.2021. d) One smart Mobile phone VIVO with one SIM vide connection no 9339805119 recovered from the possession of accd. Susanta Saha. e) One keypad Mobile phone styled as SAMSUNG with one SIM vide connection no 8170918105 recovered from the possession of accd. Santosh Das duly signed by the independent witnesses and acknowledge by the accused persons in presence of Special Executive Magistrate of SPC. The whole search seizure and labeled procedure was made in between 15.30 hrs to 16.45 hrs. On further interrogation, the above noted arrested accused persons admitted that they had been procuring the brown sugar clandestinely from Nepal area for the purpose of selling the same in high rate to their designed customers at Ghoshpukur, Islampur area for their wrongful gain during pandemic COVID time by illegal means.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely 1) Susanta Saha 23yrs s/o Sukumar Saha of Samarnagar ps, Bhaktinagar Dist, Jalpaiguri 2) Santosh Das 32yrs s/o Amar ch. Das of Namada Bagan ps, Pradhannagar Dist, Darjeeling has been involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act. I arrest them also informing them their ground of arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely 1) Susanta Saha 23yrs s/o Sukumar Saha of Samarnagar ps, Bhaktinagar Dist, Jalpaiguri 2) Santosh Das 32yrs s/o Amar ch. Das of Namada Bagan ps, Pradhannagar Dist, Darjeeling and arrange for its investigation.


