With due respect, I am to state that I am the Proprietor of M/S Sandhya Battery has been carrying business of Battery and Inverters, having showroom at 2 1/2 Mile, Sevoke Road, Near Don Bosco School More, Siliguri S.M.C, District - Jalpaiguri and storehouse located at Zila Parisad Road, Near Bottle Company, P.O. Sevoke Road, P.S. Bhaktinagar, Siliguri S.M.C, District - Jalpaiguri.

I have to lodge a complaint about house-breaking and theft in my storehouse located as mentioned above. Sir, today in the morning at about 07 am, when I was going for morning walk through road in front of my store house it was came to my notice that burglary was made in the last night or early in the morning into my storehouse by house breaking. It was also seen that the burglary was made by breaking a portion of Iron Gate of the storehouse. When I enter into the storehouse, it is seen that a large number of my goods (Business Stock) was been theft by the housebreaker/ housebreakers. The estimated value of the theft goods is Rs. 80.00 Lakhs (Rupees Eighty Lakh) only.
