Sir,

I the above named complainant begs to lodge you this FIR to the following ground and effects :-

1. That I am the above named complainant and I am complaining against the accused.
2. That the accused No: 1 is my husband.
3. That the accused No: 2 and 3 are living in my matrimonial house free of cost as the accused No: 3 and 2 declare as a staff of accused No: 1 but in reality the accused No: 2 is doing a women sexual business late at night helped by accused No: 1 and 3.
4. That right now I am not living in my matrimonial house I live in my parents house.
5. That on 9/7/21 at about 12:30 to 1:00 PM the accused No: 1 called me and my son Rohit Saha, S/o Rinku Saha stating that the accused No: 1 will pay some money to me for monthly expenses of me and my sons.
6. That accordingly I and my son went to my matrimonial house. After entering the house I came to know there evil intention. Accused No: 1 firstly caught my hair and drag me inside a room and started hitting me

with kicks and blows. At that time the accused No: 2 and 3 caught my son and started biting him mercilessly.

7. That when I fell down I became very serious. I am a patient of sugar, pressure and my health remains not well all the time. Knowing this the accused thrashed me then the accused No: 3 came into the room with a sharp knife. Then both the accused No: 1 and 3 shown me knife and tried to cut my body skin with several kicks and blows. Thereafter both accused No: 1 and 3 tried to remove my clothes and touched all my private parts of my body.
8. That seeing this I started crying for mercy but no one showed any mercy. Latter the accused No: 2 came to me and took away my gold ear rings and chain and kept it with her.
9. That somehow my son came to me and he was affected by kicks and blows and also all the accused showed knife to my son and threatening me and my son to kill us.
10. That I shouted and become senseless. Seeing this my son took me out with some neighbor people help and thereafter we went to Siliguri District Hospital.
11. That I showed to OPD where some test and medicine were given to me as my wounds internally was very serious. The doctor also wrote it's a police case which had happened to me.
12. That now I came before you asking for help and requesting you to start a police case against all the accused and also to arrest them immediately.
