Sir,

With due respect, I, Sri Rinku Saha, son of Late Amal Krishna Saha, resident of Haiderpara, Himachal Sarani, Ward no. 40 of Siliguri Municipal Corporation, Siliguri, Dist- Jalpaiguri, beg to inform you that I have been living separately from my wife resident of Rabindra Nagar, Notun Para, since 2016 and my wife lodged several cases against me and therefore I have detached relation from my wife. She always come to my office and used to lodge false case against me. I never go to my in laws house to avoid her. Since last few days my wife was threatening to me to lodge false case against me. I have CCTV in my office and you can see the exact incident of what was happening by my wife and two sons.

That today on 09-07-2021 at about 1:00 P.M. my wife namely Ruma Saha along with my two sons namely Ronith Saha (my elder son) and Rohit Saha (my younger son) came to my office at Haiderpara, Himachal Sarani, Ward no. 40 of Siliguri Municipal Corporation, Siliguri, Dist- Jalpaiguri and started to quarrel with me and using slang languages against me without any reason. My wife and younger son namely Ronit Saha hold my neck tightly and beaten me with wooden pole on my chest and back and they have also assaulted my staff Bappa Sarkar and his wife Papri Sarkar and all of them sustained injuries and took treatment from Siliguri District Hospital. I somehow

managed to escape from their hands and saved my life. Thereafter my aforesaid two sons namely Ronith Saha and Rohit Saha along with my wife forcibly snatched my bikes' key and taken away the said two bikes and the documents are lying in the said bikes (1) Hero Honda CBZ Xtreme vide Registration no WB-74 L5652 and (2) Royal Enfield Classic 350 vide Registration no WB-74 AP2840. I bear their education expenses studying in Orissa, inspite of that they were/are threatening me that they will booked me in false cases and will make my life in hell and danger.

That on 30/04/2021 my wife lodged a false complaint, Bhaktinagar P.S. Case No. 443/21 and in that case and in other cases also place of occurrence is my residence, it proves that she comes and used to tortured me.

My wife Ruma Saha along with my two sons namely Ronith Saha and Rohit Saha started threatening me since last few days, that if I will not transfer my property in their names, they will murder me and will not allow me to lead my natural life.

You are therefore requested to take appropriate legal action against my wife and two sons and save me and my life from their torture and oblige me.
