Sir,

In producing herewith one accused person namely Prakash Biswakarma(30), s/o Sri Chatra Bahadur Biswakarma of Bethgara, Itavata, PO-Salugara, PS-Bhaktinagar, Dist-Jalpaiguri along with the following seized articles as per proper seizure list:-

1. 24 (Twenty Four) Bottles of KINGFISHER Strong Premium Beer (each bottle containing 650 ML).
2. 11(Eleven) Bottles of Royal Blue Premium Whisky (each bottle containing 750 ML).

I, ASI Biswajit Saha of Bhaktinagar PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 09/07/2021 at 19.30 hrs received a source information that at Bethgara, Itavata, PO-Salugara, PS-Bhaktinagar, Dist-Jalpaiguri have gathered huge amount of liquor illegally in the open market for selling the same in the customer for his wrongful gain. This refers to Bhaktinagar PS GDE No- 497 Dated 09.07.2021 I informed I/C Bhaktinagar about the information. As per his kind instruction I along with, CVF/619 Dharmendra Roy, CVF/614 Sumit Roy and CVF/14 Labanyamoy Barman as proceeded Bethgara, Itavata, Salugara to work out the information. At 19.45 hrs we reached at the spot, sometimes after being identified by the source our police party held raid in the open market at Bethgara, Itavata, Salugara and recovered the above noted articles from the possession of above noted accused person namely Prakash Biswakarma(30). On demand he could not produce any valid license/documents in support of said liquor. He became nervous and admitted his guilt before us and stated that he sells the same in the customer since long for his wrongful gain. In presence of witnesses namely Molin Chandra Roy, s/o Sri Manoranjan Roy of Dakhin Palash, Natun Bazar, PO- Salugara, PS- Bhaktinagar, Dist.- Jalpaiguri I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 19.55 hrs to 20.35 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Prakash Biswakarma(30), s/o Sri Chatra Bahadur Biswakarma of Bethgara, Itavata, PO-Salugara, PS-Bhaktinagar, Dist-Jalpaiguri under proper section of law.
