Hence they violated the said order. Finding no any alternative way, I arrested them U/S-41 Cr.PC. after proper briefed them about the ground of arrest and supplied a copy of Memo of Arrest.

Hence, I would, therefore request you to kindly start a specific Case U/S-188 IPC r/w section 51(b) of Disaster management Act 2005 against the above noted accused persons and obliged.
