In producing herewith one accused person namely Lila Devi Sahani-38 yrs. W/O Bilash Sahani A/Pof Santoshinagar Near Machlimore, W/NO-05, PS- Siliguri, Dist – Darjeeling, P/A of Tikiyapara near Wooden Shop, W/NO-28, along with the following seized articles as per proper seizer list.

1. 20 (Twenty) pet bottles of Himalaya Gold 60up premium country spirit (each bottles containing 600ml. & MRP Rs-100/-) which was kept in one gunny bag.
2. 4 (Four) bottles of Officer Choice deluxe Whisky each bottles containing 180ml. & MRP Rs-140/-

1 PSI Sanjay Hasda of Khalpara TOP, PS Siliguri under Siliguri Police Commissionerate lodge a written complaint against the above noted person to the effect that on 02.07.2021 at 14:15 hrs. received an information from Santoshinagar Near Machlimore under Siliguri PS that one person has gathered huge quantity of illegal liquor in her house for selling the same in the open market for her wrong full gain. Diarized the fact in GD vide Khalpara TOP GDE NO -53/21, Dated-02.07.2021 . As per your kind instruction myself along with ASI Niranjan Sarkar, C/ 1187 Ganesh Sarkar and CVF/874 Pankaj Mandal and Lady Constable 1216 Puspanjali Yonzon proceeded to the PO to work out the information . At 14 :25hrs. we reached at the Santoshinagar Near Machlimore, sometimes after being identified by the source our police party held raid and recovered the above noted articles from the possession of above referred person. On demand he could not produced any valid license/documents in support of said liquor. She become nervous and admitted her guilt before us and stated that she sell the same in open marked for her wrong full gain. In presence of witnesses I seized the above noted articles from her possession after prepared proper seizer list and level and took signature of the accused person Two bottles taken as sample . (The seizure was made in between 14:30hrs. to 14:45hrs.) I arrested the accused person U/S 41 Cr. P.C and issued Memo of arrest appraising the ground of arrest by Lady Constable 1216 Puspanjali Yonzon.

I therefore request you a specific case may kindly be started against the accused person namely Santoshinagar Near Machlimore W/NO-05, PS- Siliguri, Dist – Darjeeling, P/A of Tikiyapara near Wooden Shop, W/NO-28, PS Siliguri, Dist- Darjeeling under proper section of law and arrange for investigation .
