In producing herewith arrested accused person namely Babita Rai (29) W/O Aman Rai of Howkers Corner, Ward No. 18, PS- Siliguri Dist- Darjeeling along with seized articles vize- i) 23 ( twenty three ) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 23 x Rs 100/- =RS.2300/-) as per seizure list.

I, ASI Siben Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Babita Rai (29) W/O Aman Rai of Howkers Corner, Ward No. 18, PS- Siliguri Dist- Darjeeling to the effect that on 02.07.21 at 14.25 hrs I received a source information that the above noted person was busy to sale Id liquor illegally at her house situated at Howkers Corner, Ward No. 18 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 90 dated 02.07.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with L/C-1313 Mili Roy, LCV/ 175 Pratima Das, CV/283 Prosenjit Dey left Howkers Corner, Ward No. 18 PS vide Siliguri P.S GDE NO: 91 dated 02.07.21 to verify the veracity of the information. On reaching at 14.45 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, the above noted person disclosed her identity as noted above. On searching i) 23 ( twenty three-) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 23 x Rs 100/- =RS.2300/-) which was kept concealed in her house. On being interrogation

she could not produce any valid documents in respect of the said liquor. She also stated that she is doing this liquor business since last ten (10) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.15 hrs to 15.55 hrs. On being asked she stated that she used to sale the same to locality without any valid documents as she has violated the norms of Bengal Excise Act as such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules for selling the said seized articles without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Babita Rai (29) W/O Aman Rai of Howkers Corner, Ward No. 18, PS- Siliguri Dist- Darjeeling under proper section of law and arrange for its investigate.
