Siliguri, Darjeeling, would like to inform you of the actual fact that on 1.7.2021 at 4 P.M. and today on 2.7.2021 at 5 P.M. I was beaten mercilessly and inhumanly by the above-noted persons who hit my forehead with an iron rod. As a result, I have sustained severe injuries from where profuse blood begins to flow rapidly from my injured portion, besides today, my minor son, Rohan Pasman at the age of 10 with my husband was beaten severely with a heavy rod on his head by the said persons. Moreover, they have snatched Rs/5,000 cash from me by force. Truly speaking they cause such an occurrence of and or in my family by taking advantage of my helplessness and weakness. Hence, finding no other ways, I am lodging this F.I. to your good office for favour of your stern action under the above circumstances your fruitful action regarding the above-noted matter is fervently solicited from your kind end.
