Sir,

In producing herewith one arrested person namely Rambilash Roy (55) S/O- Lt Thakko Roy, of Cooli Para, W/no.-01, near Siliguri Junction PS- Pradhan Nagar, Dist- Darjeeling, under arrest along with following articles under proper seizure list:

- (1) 13(thirteen) bottles of Himalayan Gold country sprit, containing 600 ml each bottle.
- (2) 08(eight) bottles Officer's Choice Deluxe Whisky containing 180 ml each bottle.
- (3) 07(seven) pouches Officer's Choice Deluxe Whisky containing 180 ml each bottle.

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that on 02.07.2021 at 20:55 hrs myself along with ASI Ashit Singh an force CV/131 Ranjan Sharma, CV/128 Ajay Kr Sahani, CV/223 Swapan Chettri left PS for Special mobile van duty Ps.area vide PDN PS GDE No.- 95. During mobile duty at about 21.05 hrs I received information that one person namely Rambilash Roy stored huge quantity of illegal liquor in his house-cum-Tea shop situated at Cooli Para, W/no.-01, near Siliguri Junction under Pradhannagar PS and selling the same from there. Accordingly, I shared the information to you and as per your kind instruction myself along with force rushed to the spot and tried to collect witnesses for search and seizure but due to lockdown no one was present there. Then I held raid at the above noted shop-cum-house and detained the above noted person and recovered above noted articles. On demand he failed to produce any valid document in favor of the recovered articles. On interrogation he admitted that he had been selling the same illegally since long without valid document for his illegal gain. Accordingly, I seized the above noted articles under proper seizure list and labeled in between 21.15 hrs to 21.50 hrs and arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely one Rambilash Roy (55) S/O- Lt Thakko Roy, of Cooli Para, W/no.-01, near Siliguri Junction P.S- Pradhan Nagar, Dist. Darjeeling and arrange for its investigation.
