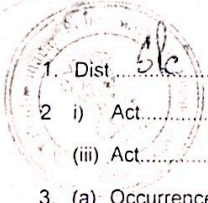

In producing herewith one Female arrested person namely (1) Baby Kundu (56) W/O Lt Shyam Kundu @ Madhu of Samar nagar battala, P.S-Pradhannagar, Dist. Darjeeling, under arrest along with following articles under proper seizure list:

- (1) 27 bottles of Himalayan Gold country spirit, containing 600 ml each bottle.
- (2) 15 bottles Officer Choice Delux Whisky containing 180ml each bottle.

I ASI Ratan Pradhan of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that on 03.07.2021 at 10.20 hrs myself along with ASI Ashit Singh and force LC/ 744 Sarada Sarki CV/131 Ranjan Sharma, CV/128 Ajay Kr Sahani, CV/223 Swapan Chettri left PS for Special mobile van duty at PS area vide PDN PS GDE No. 127 dtd. 03.7.21. During mobile duty at about 10.30 hrs I received information that one lady person namely Baby Kundu stored huge quantity of illegal liquor in her tea shop situated at Samar Nagar battala bazar under Pradhannagar PS and selling the same from there. Accordingly, I shared the information to you and as per your kind instruction myself along with force rushed to the spot and held raid at the above noted tea shop in presence of local witness and detained the above noted lady person with the help of lady constable and recovered above noted articles. On demand she failed to produce any valid document in favor of the recovered articles. On interrogation she admitted that he had been selling the same illegally since long without valid document for her illegal gain. Accordingly, I seized the above noted articles under proper seizure list and labeled in between 11.05 hrs to 11.45 hrs and arrested her.

Therefore, I request you to start a specific case under proper section of law against the arrested lady accused person namely Baby Kundu (56) W/O Lt Shyam Kundu @ Madhu of Samar nagar battala, P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
