Sir,

In producing herewith one arrested person namely (1) Budaru Barman (65) bS/O Lt Ghergheru barman og Dakshin Palash ,Natun bazaar ,P.S- Pradhannagar,Dist.Darjeeling , under arrest along with following articles under proper seizure list:

- (1) 24 bottles of Himalayan Gold country sprit, containing 300 ml each bottle.
- (2) 09 Pouch packets Officer Choice Delux Whisky containing 180ml each bottle.

I ASI Ashit Singh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that on 03.07.2021 at 15.30 hrs myself along with force CV/131 Ranjan Sharma, CV/128 Ajay Kr Sahani, left PS for Special mobile van duty at PS area vide PDN PS GDE No. 152 dtd.03.7.21. During mobile duty at about 16.05 hrs I received an information that one person namely Budaru Barman stored huge quantity of illegal liquor in his house situated at Dakshin Palash ,Natun bazaar under Pradhannagar PS and selling the same from there. Accordingly, I shared the information to you and as per your kind instruction myself along with force rushed to the spot .On seeing police party the local people fled away from the spot and held raid in his house and detained the above noted person and on search his house , recovered above noted articles. On demand he failed to produce any valid document in favor of the recovered articles. On interrogation he admitted that he had been selling the same illegally since long without valid document for his illegal gain. Accordingly, I seized the above noted articles under proper seizure list and labeled in between 16.35 hrs to hrs to 17.05 hrs and arrested him .

Therefore, I request you to start a specific case under proper section of law against the arrested accused person namely Budaru Barman (65) bS/O Lt Ghergheru barman og Dakshin Palash ,Natun bazaar ,P.S- Pradhannagar,Dist.Darjeeling and arrange for its investigation.
