
Sir,

I, SI Sushanta Dhar of Matigara PS SPC to the effect that on 09.07.2021 during performing Mobile Van duty at Shivmandir Bazar under Matigara PS area he found Three persons namely (i) Amardeep Sahani (36), S/O Raghunath Sahani of Sarban nagar, Ward No. 18, PS - SLG, Dist - DJG, (ii) Ripana Das (30), S/O Pawan Das of Patiramjote, PS - MTG, Dist - DJG, (iii) Sanjit Sarkar (28), S/O Narayan Sarkar of Patiramjote, PS - MTG, Dist - DJG under Matigara P.S area were loitering at Shivmandir Bazar under Matigara PS area without wearing mask and not maintaining social distance and violating the Govt.
