Sir, In producing herewith arrested accused person Shyamal Saha, S/O - Kartick Saha, of – Ranidanga SSB Gate No – 1, PS – Bagdogra, Dist – Darjeeling along with copy of memo of arrest and seized articles viz 30 (Thirty) bottles of Sealed Himalayan Gold Bottles 60Up Country Spirit each containing 300 Ml, Rs. 50/- each totaling amount of Rs 1500/- with proper police escort.

Today i.e 09.07.2021 at 17.20 hrs I, PSI Rantu Haldar of NBMC OP along with C/131 Kanuram Sarkar and CV/ 665 Raju Sarkar while conducting special raid against anti social elements, warrantees, ID liquor etc in vehicle no WB74/8035 at different area under NBMC OP in course of which I received an information from source that one person is selling Liquor illegally in huge quantity in a clandestine way in petty shop at Kawakhari, near Laska Bridge under Matigara PS. As soon as after receiving Cove mo (46) Dinformation I informed the matter to O/C NBMC OP and as per his order and instruction I along with force application. instruction I along with force conducted raid in petty shop of Shyamal Saha and D1 09 07 wu found he is hidden illegal liquor inside his shop and selling it to the customers in concealed manner. On demanded he failed to produce any valid papers and license of MJ 46 A(1) those articles. Hence I seized those illicit liquors U/S 102 CrPC after preparing B & Oct one proper seizure list duly signed by the witnesses as well as the accused and also iabeled the same. On interrogation, he disclosed his name as mentioned above and admitted that he procured the liquor illegally and had been selling the same illegally to the people then I arrested him u/s-41 CrPC. The search, seizure, label and arrest were made from 17.55 hrs to 18.25 hrs. Then we left the place with the arrested his person and the seized articles.

> Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Shyamal Saha, S/O - Kartick Saha, of - Ranidanga SSB Gate No - 1, PS - Bagdogra, Dist - Darjeeling and kindly arranged for its investigation.
