Sir,

In producing here with ten arrested accused persons namely namely 1. Pratik Ray(24) S/o- Jogendranath Ray of W/no-2 ,Mehata tola PS-Keht Dist-purnia, Bihar 2.Bisal Paswan(23) S/o- Basarat Paswan of Pabitra Nagar PS-Pradhan Nagar Dist- Darjeeling 3.Sajan kumar Saha (25) S/o- Dinesh Prasad Saha of Copritip tola PS-Kehat Dist Prinia Bihar 4.Munna Giri(34) S/o Bhagrasan Giri of Natun Bazar PS-Pradhan Nagar, Dist- Darjeeling 5.Manohar Singh(40) S/o-Nemo Singh of Merwas PS-nagor Dist-Nagor, Rajasthan 6.Amil sai(25) S/o Dharam Pal Sai of Krilywas PS-Choru Dist-Choru of Rajasthan 7.Joy Ray(45) S/o Sagar Ray of Natun Bazar, Pradhan Nagar Dist- Darjeeling 8. In this regard I beg to complain that on 03.07.2021 while performing K31-II van duty vide GDE No.143 Dated: 03.07.2021 I along with force had been to Darjeeling More and found that the above noted persons were gathering and loitering there without wearing mask. As they violated the order No.-647-ISS/2M 22/2020 dated 15/05/2021 and Notification number 347 - 01.S.S. /2M 21/2020 dated 3<sup>rd</sup> June, 2020 and Memo No 486-CS/2021 dated 24<sup>th</sup> April, 2021, promulgated by Govt. of West Bengal to combat with the spread of Covid-19. As finding no other alternative, arrested them U/S 41 C.r.P.C. On interrogation, they disclosed their names and address as noted above. On further interrogation, they admitted that they were aware of the Lockdown Order and restrictions imposed upon the movement of general public and vehicle to combat against the spread of Covid-19.

I, therefore, pray before you that a specific case may kindly be started against above noted arrested accused persons and take lawful action.
