Sir,

I, SI Rabindra Nath Sarkar presently posted at Pradhannagar Police Station, SPC would like to lodge this written complaint against one (01) arrested accused person namely Sk. Mostak Ahmed (20 yrs) S/o Sk. Abdul Sattar of Vill Berugram, Po-Pakurhas PS-Nanoor Dist Birbhum, who has been arrested for contravening the norms of NDPS Act and also produced the following seized articles under seizure as per seizure list:

Dated: 05.07.2021

- i) 110 gms said to be brown sugar in white color Plastic Packet printed in red color double Cow and other side double hen on the plastic packed, which is marked as Exhibit-A,
- ii) 10 gms of said to be brown sugar taken from Exhibit –A as sample as Exhibit A-1
- iii) One Still colour bag styled as "Crystal Bags".

In this regard I beg to state that today i.e. on 05.07.2021 at about 07:35 hrs myself received a secret source information that one person possesed huge quantity of brown sugar and selling the same to local customers of Siliguri Junction area. Wasting no time I diarized the information vide PDN PS NO. 236 Dt. 05.07.21 and consequently informed of the tip off to you and as per your kind instruction. myself along with SI Binup Mahato, ASI Debasish Das, ASI Ratan Pradhan, CV-131 Ranjan Sharma, CV-223 Swapan Chhetri, CV-128 Ajay kumar Sahani all of Pradhannagar PS, SPC left for Siliguri Junction under Pradhannagar P.S. area by Govt. vehicle No WB24A 6765 to verify the veracity of the information vide Pradhannagar P.S. CC No-1211/21, and Pradhan nagar P.S. GDE. No. 237, Dt- 05.07.2021 at 7:45 hrs along with the IO Kit including Weighing machine etc. At about 07:55 hrs we arrived at Siliguri Junction and called two independent witnesses namely 1) Rajib Balmiki (22) S/o lt. kishor Balmiki of Baghajotin Colony, Ward no-2, P.S. Pradhan nagar, Dist- Darjeeling, 2) Washim Akram (28) S/o Md. Chandu, of Gurung Basty P.S.- Pradhan nagar, Dist- Darjeeling and disclosed our identity and informed them about the information in hand and requested them to accompany us in the whole process of search and seizure if necessary. As identified by the source we had been to Siliguri Junction near NBSTC out gate. Thereafter I gave him the option to be searched before a Magistrate or a Gazetted Officer upon which he agreed to be searched before a gazette officer and I also gave him a written information in this regard and read it out the same and he give consent verbally.

Consequently I contacted to the Sri Subasisi Chaki ,I/C Pradhannagar PS SPC for come to the spot and supervise the entire process of search and seizure. Sri Subasisi Chaki ,I/C PS SPC arrived at the spot at 08:45 hrs, thereafter the process of the search was started before conducting search self search of me and Sri Subasisi Chaki, I/C Pradhannagar PS SPC had been conducted by the detained person and a memo had been given to him to the effect that and he could not find any other offending things except arms and IO kit and weigh machine.

On searched the person I found a white color plastic packet printed one side double Cow and other side printed double Hen both in red colour contains said to be brown sugar from still color bag styled as Crystal bags on his back .Thereafter I started weighting the recovered said to be brown sugar containing with a weighing machine kept with us for the purpose of weighing and on weighing total 110 gms said to be brown sugar recovered from the possession of Sk. Mostak Ahmed (20yrs) S/o Sk. Abdul Sattar of Vill Berugram, Po-Pakurhas PS-Nanoor Dist Birbhum.

Thereafter I seized the recovered 110 gms of said to be brown sugar which is marked as A and 10gms of said to be brown sugar Marked as Exhibit A-1 as sample taken from Exhibit-A before of the detained person, independent witnesses, I/C Pradhannagar PS, and put signature of all persons including me. The seizure was made in between 09:35 hrs to 10:45 hrs from the Possession of accused person namely Sk. Mostak Ahmed (20 yrs) S/o Sk. Abdul Sattar of Vill Berugram, Po-Pakurhas PS-Nanoor Dist Birbhum by preparing a seizure list duly signed by the independent witnesses & accused person. Consequently the apprehended above noted person had been arrested by me at 10:55 hrs by issuing a proper Arrest Memo for contravening the norms of NDPS Act and returned back to P.S. with the arrested accused person.

In the above circumstance, I pray before you to take the seized articles and sample & accused namely Sk. Mostak Ahmed (19yrs) S/o Sk. Abdul Sattar of Vill Berugram, Po-Pakurhas PS-Nanoor Dist Birbhum started a specific case against the arrested accused person under proper section of law and arrange for
