In producing herewith 05(five) accused persons namely (1) Biswajit Singha Roy (42) S/O Lt. Amaranda Singha Roy of Pati Colony, Road No. 01, Ward No. 47, PS- Matigara, Dist-Darjeeling (2) Rohit Kumar (34) S/O Nagendar Sah of Vidhya Chakra Colony, Back side of Sanjeevani Hospital, Ward No. 44, PS- Bhaktinagar, Dist- Jalpaiguri (3) Ajay Kumar Mahato, S/O Sri Laxmi Narayan Mahato, of Rampur Near Basupati, Ward No. 15, PS- Harlaki, Dist- Nantoni, Bihar (4) Ramayan Sah (38) S/O Geni Sah of Dasharat Pally, Near Kalimandir, Ward No. 44, PS- Bhaktinagar, Dist- Jalpaiguri (5) Mukesh Kumar Roy (34) S/O Promod Maharaj of Purbo Karaibari Chhat, Milan More, Champasari, PS- Pradhannagar, Dist- Darjeeling, under arrest.

Lt. SI Arindam Chatterjee of Panitanki Town out Post, PS- Siliguri, SPC do hereby lodge a written complaint against the above noted accused persons to the effect that on 02.07.2021 at about 18:15 hrs while performing mobile patrolling duty at Bidhan Market Auto Stand area and found the above noted arrested persons were moving here and there without using face mask. On being asked they disclosed their name as (1) Biswajit Singha Roy (42) S/O Lt. Amaranda Singha Roy of Pati Colony, Road No. 01, Ward No. 47, PS- Matigara, Dist-Darjeeling (2) Rohit Kumar (34) S/O Nagendar Sah of Vidhya Chakra Colony, Back side of Sanjeevani Hospital, Ward No. 44, PS- Bhaktinagar, Dist- Jalpaiguri (3) Ajay Kumar Mahato, S/O Sri Laxmi Narayan Mahato, of Rampur Near Basupati, Ward No. 15, PS- Harlaki, Dist- Nantoni, Bihar (4) Ramayan Sah (38) S/O Geni Sah of Dasharat Pally, Near Kalimandir, Ward No. 44, PS- Bhaktinagar, Dist- Jalpaiguri (5) Mukesh Kumar Roy (34) S/O Promod Maharaj of Purbo Karaibari Chhat, Milan More, Champasari, PS- Pradhannagar, Dist- Darjeeling.

On interrogation, it could be learnt that they had no any reason to moving here and there without using facial mask during Pandemic disaster situation and unlock period. Over that some of the local peoples were also annoyed with the accused persons by such an act. Finding no other alternative, I arrested them U/S 41 Cr. P. C as there was no scope to give notice under 41 (A) Cr. P. C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They negligently and malignantly move to spread infection of any decease dangerous to life during Pandemic disaster situation and unlock period.

Since they violated the order of Govt. of West Bengal duly promulgated in order No. 753/11-ISS/2M-22/2020 dated 20/06/2021 and No. 647-ISS/2M-22/2020 dated 15/05/2021 read with No 707-ISS/2M-22/2020 dated 15/05/2021 and No. 753-ISS/2M-22/2020 dated 14/06/2021. The above noted persons have intentionally disobeyed the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic (COVID-19) in the whole of the country. Accordingly I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the provisions of the above mentioned all rules and formalities. Now I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 201(1) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation in the case.

Under the above facts and circumstances I pray that a specific case may kindly be initiated against (1) Biswajit Singha Roy (42) S/O Lt.
