Sir, In Producing herewith the following seized articles viz:-

1. Total 375 (three hundre seventy five) boxes in each liquid vaporiser mosquitoes oil container marked as "Good knight power active + said to be counterfeit having batch No. VA20030901 manufacturing date 03/2021 net contains 45 ml marked as exhibit "A".
2. 02 (two) boxes taken as sample in each liquid vaporiser mosquitoes oil container marked as "Good knight power active + said to be counterfeit having batch No. VA20030901 manufacturing date 03/2021 net contains 45 ml marked as exhibit "A 1".

I, ASI Prasanta Bardhan of Enforcement Branch under Siliguri Police Commissionerate do hereby lodge this written complaint against one **Mohan Prasad Das S/O Bideswar Prasad Das prop. of "laxmi narayan store" at Nivetita market in front of Siliguri Dist. Hospital' Siliguri and residing at Ghugnimore, Haidar para ward No.47, PS. Bhaktinagar Dist. Jaipauri** to the effect that on 03/07/2021 on acting secret source information that huge quantity of liquid vaporiser mesquites oil of Good knight power active" storing and selling at Nivedita market Siliguri without any valid documents in his shop styled as "laxmi narayan store noted above. This information shared to ACP EB and other superiors of EB SPC. As per direction of ACP, EB/SPC, Myself along with SI Goutam kundu SI Prodip Charoborty, ASI Ashok Biswas, Cons. 424 Manik Roy all of EB, SPC had been to Siliguri PS vide EB SPC MCC No 80/21 dated 03/07/2021 and the matter informed to I/C Siliguri PS vide Siliguri PS GDE 167 dated 03/07/2021 for PS police assistance to verify the veracity of this information. Accordingly EB team with SI Gopal Mandal and his force of Siliguri PS has been to Nivedita Market Siliguri. As per source identification myself along with other officer and force held a raid in the shop styled as "laxmi Narayan store" at Nivetita market and recovered huge quantity of liquid vaporiser mesquites oil of Good knight power active". On seeing the police party the owner of shop noted above manage to filed away from his shop and found one worker of shop present in the shop. On being asked the worker disclosed his name Raja Bhagat (20 yrs) S/o Garak Bhagat is failed to produce any valid documents or license for the same thereby, violating the provisions of law in support of Storing and Selling the same to the public for his wrongful gain. The above noted owner of shop storing and selling liquid vaporiser mosquitoes oil said to be container marked as "Good knight power active + mosquitoes oil.

Accordingly I seized the items u/s 102 of Cr.P.C. in presence of witnesses 1. Raja Bhagat (20 yrs) S/o Garak Bhagat of Ram nagar Colony PS New Jalpaiguri Dist. Jalpaiguri and 2.C/424 Manik Roy of EB SPC being prepared proper seizure list with label. The seizure was made in between 14.45hrs. to 15.15 hrs.

Hence it is pray that a case may kindly be lodged against **Mohan Prasad Das S/O Bideswar Prasad Das prop. of "laxmi narayan store" at Nivetita market in front of Siliguri Dist. Hospital' residing at Ghugnimore, Haidar para ward No.47, PS. Bhaktinagar Dist. Jaipauri** under proper section of law and arrange for its investigation.
