Sir,

In producing herewith arrested accused person namely Biswanath Das (37) S/O Naresh Das^{@ Nayan} of Ramghat Natunpara Ward No. 05 , PS- Siliguri Dist- Darjeeling along with seized articles vize- i) 21 (twenty one) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 21 x Rs 100/- =RS.2100/-) as per seizure list.

I, SI Uday Chakraborty of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Biswanath Das (37) S/O Naresh Das of Ramghat Natunpara Ward No. 05, PS- Siliguri Dist- Darjeeling to the effect that on 03.07.21 at 20.30 hrs I received a source information that the above noted person was busy to sale Id liquor illegally at his shop situated at Jalpaimore under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 188 dated 03.07.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Siben Sarkar, CV/283 Prosenjit Dey left Jalpaimore vide Siliguri P.S GDE NO: 189 dated 03.07.21 to verify the veracity of the information. On reaching at 20.50 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, the above noted person disclosed his identity as noted above. On searching - i) 21 (twenty one) sealed bottles of Himalayan Gold 60 up country spirit containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 100 each (Amounting of 21 x Rs 100/- =RS.2100/-) which was kept concealed in his shop. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since last six (06) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and

label was made in between 21.05 hrs to 21.50 hrs. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act as such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules for selling the said seized articles without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Biswanath Das (37) S/O Naresh Das of Ramghat, Natunpara Ward No. 05 , PS- Siliguri Dist- Darjeeling under proper section of law and arrange for its investigate.
