In producing herewith one person namely Sanjay Chettri 32yrs s/o Bishnu Chettri r/o Sanyashi Than PS, Bagdogra, Dist- Darjeeling under arrest along with seized articles viz.

1. 10 (Ten) bottle Kingfisher Strong Premium Beer (each bottle containing 650 ml.) marked as Exhibit "A" from which 01 bottle randomly taken out as sample and marked as Exhibit "A -1",
2. 05 (five) bottles of Mc Dowell's No Celebration Matured XXX Rum (each bottle containing 180 ml.) marked as Exhibit "B" from which 01 bottle randomly taken out as sample and marked as Exhibit "B-1",
3. 36 (Thirty six) bottles of Black Cat Special Rum (each bottle containing 180 ml.) marked as Exhibit "C" from which 01 bottle randomly taken out as sample and marked as Exhibit "C-1",
4. 06 (six) bottles of Blue Time Premium Whisky (each bottle containing 750 ml.) marked as Exhibit "D" from which 01 bottle randomly taken out as sample and marked as Exhibit "D-1",
5. 05 (five) bottles of Royal Celebration of Special Whisky (each bottle containing 750 ml.) marked as Exhibit "E" from which 01 bottle randomly taken out as sample and marked as Exhibit "E-1",

I, ASI Jakirul Islam of Bagdogra Police Station, SPC do hereby lodged this complaint against the above noted arrested person namely Sanjay Chettri 32yrs s/o Bishnu Chettri r/o Sanyashi Than PS, Bagdogra, Dist- Darjeeling to the effect that today i.e, on 10.07.21 at 18.05 hrs acting a tip of secret reliable source information that one person mentioned above that he possessing and selling huge quantity of illicit liquor on his house located at Sanyashi Than to his designated customers. Accordingly, I shared the information with you and diarized the fact vide GDE no 558 and as per your kind instruction, I along with force immediately rushed to the Sanyashi Than area the house under Bagdogra PS, to work out the information. On reaching there at about 18.25 hrs, I contacted with my source and subsequently being pointed the house of Sanjay Chettri seeing the police party some of customers run to fied away from his house somehow we managed to apprehended the above noted person from the house and on search the above noted huge quantity of illicit liquor on different brands has been recovered from this house which was kept concealed on his house on demand he failed to produce any valid documents/papers in support of possessing and storing of huge quantity of the illicit liquors. Accordingly, I seized the above noted huge quantity of illicit liquor on different brands under proper seizure list in presence of witnesses and labelled and also arrested him issuing memo of arrest. The whole process of seizure and labelled was made in between 18.35 hrs to 19.05 hrs.

Therefore, I pray before you that a specific case under proper section of law may kindly be started against Sanjay Chettri 32yrs s/o Bishnu Chettri r/o Sanyashi Than PS, Bagdogra, Dist- Darjeeling and arrange for its investigation under proper section of law.
