Subject: FIR

Sir,

In producing herewith one accused person namely Umer Ali (26), S/O- Md. Kabir, of Dhandegachh, PO - Dhandegachh, PS - Chopra, Dist - Uttar Dinajpur under arrest and seizer list and seized articles, as noted below

1. One Truck (Eicher, Mini Dumper) bearing regd no. WB 91 / 2821 loaded with sand.

I ASI Prembhakta Mallick of NBMC OP Under Matigara PS beg to lodge a written complaint against the above noted accused person to the effect that today 10.07.2021 at 13.55 hrs I along with C/ 63 Raj Orawn & C/865 Himu Roy detailed for performing mobile van duty vide MCC No 1242/2021 Dtd. 10.07.2021. In course of my mobile van duty at about 14.35 hrs I received information from my source that one truck loaded with Sand coming from Gaisal ghat toward Siliguri without any document. Accordingly I informed the matter to O/C NBMC OP over telephone and as per his direction, I along with force arrived near Gaisalghat area on 10.07.2021 at 15.25 hrs to verify the veracity of information and found one track loaded with sand coming from Gaisalghat. Seeing the Police party the driver of that track in question tried to flee away, but we managed to intercept the above noted truck. On interrogation, the above noted person disclosed his name and identity as noted above. On being asked, the above noted accused person failed to produce any valid document for possessing the sand inside the truck. There is sufficient reason to believe that the above noted driver cum owner have stolen this sand from Gaisal Ghat without any legal royalty/papers as per rule, for selling clandestinely. Accordingly, I seized the said truck loaded with sand under proper seizure list and arrest the above noted person U/S 41 Cr.P.C informing him the ground of arrest after issuing Memo Of arrest. The search, seizure and arrest were made in between 15.50 and 16.15 hrs on 10.07.2021.

Under this circumstance I pray a specific case against the above noted accused person may kindly be started and arrange for its investigation.
