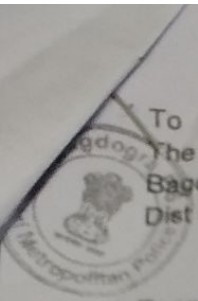

Respected Sir,

I, Sri Shib Kumar Bhakta (Mobile No. 8101519599), Son of Ram Narayan Bhakta, aged about 45 years, Hindu by religion, resident of Vill. Kestopur, chowpukuria colony, P.O. & P.S. Bagdogra, Dist. Darjeeling, after occurrence of incident mentioned below 9 am residing at Vill. Barabhita, Bengdubi, P.O. Bengdubi, P.S. Bagdogra, Dist Darjeeling beg to report you the following facts:-

- 1) That on 05.07.2021 I purchased homestead land measuring 8.66 decimals together with one pucca house having 6 (Six) rooms, situated at Vill Kestopur, Chowpukuria Colony, P.O. & P.S. Bagdogra, Dist. Darjeeling under Mouza- Chowpukuria, L.R. Plot No.345, L.R. Khatian No.293, from its registered owner Sri Ganesh Sharma, Son of Late Chandeswar Sharma of Vill. Kestopur, Chowpukuria colony, P.O. & P.S. Bagdogra, Dist. Darjeeling at and for the price of Rs. 7,50,000/- (Rupees Seven Lakh Fifty Thousand) by virtue of a registered Sale Deed in book no. 1, Document no. 040304220 for the year 2021.

After such purchase said Vendor Sri Ganesh Sharma handed over the possession of the said landed property to me and I took possession of the same and I entered into my said house on 05.07.2021 and shifted my entire house articles and things to my said house. Thereafter I installed and set up C.C.TV camera within my house premises on the outside wall of the door of my house which was functioning.


- 2) That since after purchase the said landed property by me the following persons who are the organized land brokers of that area started to threat me by saying that why I purchased that property without their permission and without giving key money G.T. tax to them and started to put me in fear by saying that they will murder me and occupy my said landed property if I fail to pay of Rs. 10,00,000/- (Rupees Ten Lakh) to them and since that time they started to demand Rs. 10,00,000/- from me and started to pressurize me to pay said amount of money to them.

But I refused to pay the any amount of money to them. So they openly threatened me that they would occupy my said landed property in very near hand and would murder me.


- 3) That on 07.07.2021 at about 9:00 AM I went to Market for purchasing some articles which is far away from the area of my said land, keeping those rooms of my house under lock and key.
- 4) That on the same day i.e. on 07.07.2021 at about 11:35 AM when I was in the market the aforesaid 9 (Nine) persons criminally trespassed into my said house premises forming unlawful assembly. Thereafter they broke all the locks of my rooms and entered into the rooms and forcefully occupied my aforesaid land and house. They stole the following cash and articles owned by me from my room:-
 - a. Cash of Rs.57,000/- kept in a tin box in my room.
 - b. Different Gold Jewellery / ornaments total 10 bharis total worth Rs. 3,00,000/- (approx).
- 5) That they dispossessed me from my said land and house and took possession of the same illegally and forcefully for their wrongful gain.
- 6) That I returned to my house on that day at about 1:00 PM and found that they already illegally occupied my said house and stole away the aforesaid cash and articles. Thereafter, I requested them to leave from my house and to return the such




- cash amount and my aforesaid gold ornaments to me but they denied to do so and drove out me from there by dragging me pulling my hands and hairs and threatened me by saying that they will murder me if I claim my said landed property. But now they are demanding of Rs. 15,00,000/- (Rupees Fifteen Lakh) from me to return back the possession of my said land and house and said cash and gold ornaments.
- 7) That all such incidents captured in the CCTV footage and I transhifted the same in pen drive for evidence and proof.
 - 8) That since they then have been forcefully restraining me from entering into my said land and house.
 - 9) That today at about _____, I was standing near my said house and was seeing my house from outside. At that time they rushed there seeing me and started to beat me by fists, blows and kicks and I fell down on the ground. Thereafter again they assault me by lathi, leather belt, fists, blows and kicks. Anyhow I managed to free from their hands and due to fear I fled away from there. I sustained severe injuries on my person due to such assault.
 - 10) That they committed the aforesaid offences and still committing offences in pursuance of their criminal conspiracy and in furtherance of their common intention.
 - 11) That the Xerox copies of my said deed and khatian of said vendor relating to said property and the said pen drive are enclosed herewith.

I, therefore, request you to kindly take necessary steps against the aforesaid culprits persons for the commission of the aforesaid offences and recover the aforesaid theft cash amount and gold ornaments from them and also take necessary steps to oust them from my house and also take necessary remedial actions / steps so that I may get back my aforesaid landed property.
