Sir,

In producing herewith the following Four (04) arrested accused persons namely 1) Md Tammana @ Gullu (29y) S/O Lt Mojibul Haque of Gas Godwan ,Sukantapally,P.S- Matigara,Dist.Darjeeling,(2) Subash Hembram (26y) S/O Lt Samai Hembram of Do,(3.) Md Mannan (26y) S/O Lt Mojibul Haque of Do (4) Krishna Sah @ Kalu (29y) S/O Lt Dahaaru Sah of Rajib nagar near Darjeeling More P.S. Pradhan nagar, Dist- Darjeeling along with the following seized articles:

- i) One iron made "Khukri " having length 13" (approx) including wooden butt having length 6" (approx), from the possession of Md Tammana @ Gullu ,from back side of his vest .
- ii) One iron "Hasua" having length 12" (Approx), including wooden butt having length 7.5" (approx), from the possession of Subash Hembram , from back side of his shirt .
- iii) One Iron made "Sabol " having length 25" (approx) from the possession of Md Mannan ,from back side of his vest .
- iv) One Iron made "Hammer "having length 3.5" including Bamboo handle length 14" (approx) from the possession of Krishna Sah @ Kalu ,from back side of his shirt .

I, ASI Ashit Singha of Pradhanagar P.S, SPC would like to lodge this written complaint against the above noted accused persons to the effect that today i.e, on 10.07.21 at 22.15 hrs I received secret source information that 10/12 persons were assembled in the dark place of Ramnarayan Play ground ,Gurung Busty under Pradhan nagar P.S. with deadly weapons with a view to commit dacoity . Accordingly without waste any time I informed the matter to you and dirised the matter vide PDN PD GDE No. 601 dtd.10.07.21 and as per your kind instruction myself along with ASI Ratan Pradhan, ASI Debasish Das, CV/223 Swapan Chettri, CV/131 Ranjan Sharma, CV/128 Ajay Sahani, CV/646 Baban Ch Das left from PS for Ramnarayan Play ground ,Gurung Busty to verify the veracity of the information and to work upon it. We reached near the spot as confirmed by the source at about 22.35 hrs and stopped our vehicle at a considerable distance from Ramnarayan Play ground ,Gurung Busty and we started walking towards the Ramnarayan Play ground ,Gurung Busty with due care so that no one could anticipate our movement. At about 22.45 hrs and we reached at Ramnarayan Play ground, Gurung Busty found a group of 10/12 persons assembled and gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing in multiple directions. Somehow, after a hot chase we could able to apprehend the 04 (Four) persons noted above. On interrogation they disclosed their identity and they also stated that they along with their other associates assembled there with a view to commit dacoity after making full preparation in a house at adjacent area. Thereafter all the apprehended persons were searched and due to late night I could not found any independent witness to be present at the time of search and seizure. During search I found the above noted articles from their possession and seized the same .

All the articles were seized between 23.05 hrs to 23.35 hrs issuing a proper seizure list duly signed by the accused persons. Thereafter all the persons were arrested with proper memo of arrest.

Under the above circumstances, I pray before you that a specific case may kindly be started against the 04 (Four) accused persons namely 11) Md Tammana @ Gullu (29y) S/O Lt Mojibul Haque of Gas Godwan ,Sukantapally,P.S-Matigara,Dist.Darjeeling,(2) Subash Hembram (26) S/O Lt Samai Hembram of Do,(3.) Md Mannan (26) S/O Lt Mojibul Haque of Do (4) Krishna Sah @ Kalu (29) S/O Lt Daharu Sah of Rajib nagar near Darjeeling More P.S. Pradhan nagar, Dist-Darjeeling and 8/9 other persons and arranged for its investigation.
