Sir,

In producing herewith one accused person namely Doma Sherpa (39) W/O- late Neema Sherpa of Kunjan Restaurant, Kalchakra Road, Salugara P.S.- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

- 1) 02 (two) bottles of Kingfisher Strong premium beer each bottle containing 650 ML.
 - 2) 02 (two) bottles of Officer Choice Deluxe Whisky each bottle containing 750 ML.
 - 3) 01 (one) bottle of Magic Moment Vodka containing 750 ML.
 - 4) 02 (two) bottle of TUBORG Premium Beer Strong each bottle containing 650 ML.
 - 5) 01 (one) bottle of royal castle whisky containing 750 ml.
 - 6) 01 (one) bottle of Mac Dowell's Rum No whisky containing 750 ML.
 - 7) 01 (one) bottle of Royal Stag Whisky containing 750 ML.
 - 8) 01 (one) bottle of Bagpiper whisky containing 750 ml.
 - 9) 02 (two) bottles of old Monk Rum XXX each bottle containing 750 ML.
 - 10) 02 (two) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml.

I, SI Sibdhan Karmakar of Bhaktinagar PS PC lodged a written complainant against Doma Sherpa (39) W/O- late Neema Sherpa of Kunjan Restaurant, Kalchakra Road, Salugara P.S.- Bhaktinagar Dist- Jalpaiguri to the effect that today i.e. on 10.07.2021 at 14.35 hrs received a source information that one Lady of Salugara Bazar has stored huge amount of liquor illegally at her Restaurant name and style as "Kunjan Restaurant" for selling the same to her design customer for her wrongful gain. Accordingly the fact is diarized vide Bhaktinagar P.S. GDE No-557 Dated 10.07.2021 and informed the fact to I/C Bhaktinagara P.S. and as per his kind instruction I along with LSI Niden Sherpa, ASI Biplab Kumar Das, CV-935 Biplab Roy, CV-614 Sumit Roy left for Salugara to work out the information. At 14.45 hrs we reached at the spot and after a while identified by the source I conducted raid in the Kunjan Restaurant of Doma Sherpa (39) W/O- late Neema Sherpa of Kalchakra Road, Salugara P.S.- Bhaktinagar Dist- Jalpaiguri and recovered the above noted articles from the possession of above noted accused person namely Doma Sherpa (39) W/O- late Neema Sherpa of Kunjan Restaurant, Kalchakra Road, Salugara P.S.- Bhaktinagar Dist- Jalpaiguri. On demand she could not produce any valid license/documents in support of said liquor. On interrogation she stated that she used sale the same to her design customers since long for his wrongful gain. Accordingly In presence of witnesses I seized the same as proper seizure list duly sign by the witnesses with the help of LSI Niden Sherpa. The seizure was made in between 15.05 hrs to 15.45 hrs. Thereafter I arrested the said accused person with the help of Lady SI Niden Sherpa u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses after observing all sorts arrest rules.

I therefore request you a specific case may kindly be started against the accused person namely Doma Sherpa (39) W/O- late Neema Sherpa of Kunjan Restaurant, Kalchakra Road, Salugara P.S.- Bhaktinagar Dist- Jalpaiguri under proper section of law.
